There is no income-qualification required for attendance. ***Unemployment Appeal Legal Advice Clinic*** - service for people who have already had a hearing with the Unemployment Law Judge and have also requested reconsideration and it has been denied. BEFORE filing an appeal with the Minnesota Court of Appeals, call or attend a clinic and get advice about how to proceed.
