Collaboration between the Minnesota District Court and the Minnesota Chapter of the Federal Bar Association to help provide civil pro se litigants with an opportunity to have a meaningful consultation with a volunteer lawyer. Parties may be referred to the program by letter from court after filing a civil case in the District of Minnesota.
