Introduction

Mission: CALCO libraries work cooperatively to promote and enhance library and information services in state government through our unique and diverse collections.

The Capitol Area Library Consortium (CALCO) is a group of libraries and information centers serving the executive, legislative, and judicial branches of Minnesota state government and the citizens of Minnesota. CALCO welcomes other libraries, organizations, and individuals as associate members, who may attend meetings and educational programs.

CALCO was formed in 1973 to encourage cooperation among the government libraries. Today CALCO libraries belong to a statewide on-line library catalog (MnPALS), share information resources among CALCO libraries and statewide through Minitex, provide Internet guidance and leadership, cooperate in acquiring federal depository documents and other materials, participate in long range planning, advise on the development of state government libraries, and offer continuing education programs.

This directory identifies the member libraries of CALCO, their staff, and their public services policies. It also provides contact information for associate members. We hope that this directory will help to distribute Minnesota state government information to the library community and the citizens of Minnesota.

We transcribe books for Post-Secondary, K-12, vocational, informational and leisure requests on a statewide basis. Access to collection is limited to those having qualifying physical print disabilities as certified by the National Library Service (LC). Braille and audiobooks are available in a number of accessible special formats.

ABOUT

The Communication Center is a unique entity serving persons with physical print disabilities. Our Braille Department serves primarily Kindergarten through 12th grade students with visual disabilities. Our Audioservices Division serves primarily adults to make print records accessible. We maintain a strong partnership with Minnesota Department of Education and our larger organization (SSB) is a division of the Minnesota Department of Employment and Economic Development (DEED). Our regional library is The Minnesota Braille and Talking Book Library Catalog that distributes a variety of accessible materials from the

National Library Service. The Communication Center distributes and repairs audio playback equipment and accessories for qualifying Minnesotans. Radio Talking Book provides closed circuit 24/7 radio programming.
