

CITY OF BEMIDJI POLICE DEPARTMENT

SECURITY SERVICES AGREEMENT

Bemidji Independent School District 31 hereinafter referred to as the “Premises Management Entity” hereby contracts with the City of Bemidji Police Department, hereinafter referred to as “The Bemidji PD” for security services of one or more of its police officers during Minnesota State Fiscal Year 2020 for the purpose/events held for **BISD 31**.

WITNESSETH:

IN CONSIDERATION of the mutual covenants hereinafter set forth, the parties agree as follows:

A. SECURITY SERVICES:

1. The Bemidji PD agrees to provide law enforcement services by providing licensed police officer(s) to Premises Management Entity at the location described above for the fiscal year **2020** for the costs and fees provided below.
2. Premises Management Entity will notify the Bemidji PD with:
 - a. Date of the event
 - b. Type of Event
 - c. Number of officers requested
 - d. Hours during which officers are required to be present
3. Email or verbal correspondence between the Premises Management Entity and the Bemidji PD will serve as contractual documentation for billing.
4. **It is hereby agreed upon and understood that the SRO/security are not a part of routine student discipline decisions in policy and in practice during the school day.**

B. PAYMENT AND BILLING:

1. Rate of Pay: Premises Management Entity shall pay the City of Bemidji the following hourly rate for each officer employed under this agreement, based upon the officer’s hourly overtime rate and the value of attendant fringe benefits: **\$75.00 per hour, per police officer.**
2. Billing: The Bemidji PD shall bill the Premises Management Entity for services provided at each requested event by mailing said billing, regular mail, to the Premises Management Entity. Premises Management Entity shall reimburse the Bemidji PD for services within ten working days of the billing date by making payment directly to the City of Bemidji at City Hall, 317 4th St. NW, Bemidji, MN, 56601.

C. AUTHORITY OF OFFICER(S):

In providing security services for events contemplated under this agreement, the officer(s) so employed shall have all the powers and authority by law in this state to licensed police officers acting in their regular course of duty.
