**Nomination and  
Selection Criteria**

One woman veteran will be recognized as the Minnesota Woman Veteran of the Year. Nominations will be accepted from the public.

A Minnesota Woman Veteran of the Year is someone who:

- Honorably served in the United States military.
- Displays leadership and supports women veteran issues.
- Is a serving citizen in her Minnesota community.

Nomination forms must include the nominee's general information along with a brief narrative explaining why the veteran is being nominated for the award. Nominations not selected may be retained for future award consideration.

Nominations may be submitted by any Minnesota resident. Submissions from Minnesota veterans, Veteran Service Organizations (VSOs), County Veterans Service Officers (CVSOs), and other veteran groups are encouraged.
