- Ob daim Affidavit (Tsab Ntawv Pov Thawj) los ntawm lwm tus neeg uas tau ua tub rog nrog tib pab Special Guerrilla Units (SGU) los sis Irregular Forces thiab paub txog tus neeg tuag txoj kev ua tub rog.
