# Purpose of this call

### **Feedback from partners:**

• Biggest need is clarity/guidance on federal funding and policy changes

### While we can't provide clarity right now, we can:

- Share the information we have access to
- Provide a space for others to share information and strategies
- Build a support network of people working through similar problems

# Federal Funds Response Work

#### Tracking guidance – which stem from executive orders

• DEI, gender, climate the primary focus

#### Tracking reimbursement blockages:

- Paused for review consistency administration priorities
- Reimbursement portal down, no response from federal agencies

#### Tracking Cancellations: 2 CFR §200.340(a)(4)

• "The Federal award may be terminated in part or its entirety... by the Federal agency ... pursuant to the terms and conditions of the Federal award, including ... if an award no longer effectuates the program goals or agency priorities."

#### **Tracking NOFOs:**

- IIJA/IRA: some fully removed, some due dates amended to past dates, some flagged for review, some renamed; there are still ~45 IIJA funding opportunities open, majority from USDOT and DOE
- General: about half of the grants newly posted on grants.gov are DOD research grants

## **Executive Orders**



Sec. 2. Policy. It is the policy of the United States...(e) to eliminate the "electric vehicle (EV) mandate"...Sec. 7. Terminating the Green New Deal.



- Sec. 2. Implementation. (a) The Director of [OMB]... shall coordinate the termination of all discriminatory programs, including illegal DEI and "diversity, equity, inclusion, and accessibility" (DEIA) mandates, policies, programs, preferences, and activities....
- Align agency or department programs, activities, policies, regulations, guidance, employment practices, enforcement activities, contracts (including set-asides), grants, consent orders, and litigating positions with the policy of equal dignity and respect identified in ... this order.

# Internal Guidance

### March 12, 2025

Guidance for competitive award selections made after Jan. 20, 2021, "that do NOT have fully obligated grant agreements or cooperative agreements in place." Guidance <u>does</u> apply to "selections with partially obligated grant agreements."

Flag activities for removal:

- "Project activities such as equity analysis, green infrastructure, bicycle infrastructure, EV and/or EV charging infrastructure.
- "Project purpose or primary project benefits include equity and/or climate such as- projects that purposefully improve the condition for EJ communities or actively reduce GHG emissions."

## Other funding actions Indications of agency and administration priorities and direction

- National Electric Vehicle Infrastructure (NEVI): suspended approval of plans
- <u>Congestion Pricing attempted cancellation</u> (New York City)
- "EPA Administrator Lee Zeldin Cancels 21 Additional Grants in 3rd Round of Cuts with DOGE, Saving Americans More than \$116M" (3/4/25)
- Staff cuts
  - 4% at National Highway Traffic Safety Administration (NHTSA)
  - DOT Safety Regulation staff
  - Proposed 65% cut at EPA

## Other funding-adjacent actions Indications of agency and administration priorities and direction

- The EPA "<u>will reconsider the Model Year 2027 and Later Light-Duty and Medium-Duty Vehicles regulation and Greenhouse Gas Emissions Standards for Heavy-Duty Vehicles.</u>" (3/12/25)
- Revocation of Biden-era DOT guidance to prioritize "<u>disadvantaged and</u> <u>underrepresented groups in the planning, project selection and design process</u>" (3/10/25)
- Rulemaking: "<u>Removal of National Environmental Policy Act [NEPA] Implementing</u> <u>Regulations</u>" (2/25/25)
- Proposed cut to electric vehicle (EV) tax credits as part of budget reconciliation push

# What does all this mean?

- Grants with signed agreements appear to be somewhat stable for the time being
- Some grants may be terminated for convenience—check terms and conditions
- Stay consistent with terms and conditions
- Get any directives in writing
- Know that calls may be recorded
- Court cases in progress
- Reporting and funding applications: anticipate use of AI screening for key words.

# Al screening for words and themes

- Analysis has shown that words associated with themes in issued executive orders and federal agency guidance are being removed or replaced on federal websites.
- Federal agencies may be conducting Al screening for these or similar words in federal grant applications and reporting.
- Applications and reports that omit these words or themes may not trigger additional review.
