## Federal Developments

- There are a <u>variety of new restrictions</u> on wind and solar developments, including new political reviews, bird-death investigations, and permit withdrawals.
- Chuck Grassley (R-Iowa) <u>placed a hold</u> blocking U.S. Department of Treasury nominees in response to the administration's efforts to rewrite "begun construction" rules, as directed in a recent executive order.
- The <u>VA</u> and <u>FEMA</u> terminated most of their collective bargaining agreements.
- The <u>Bureau of Labor Statistics secretary</u> was fired after the most recent BLS jobs report was released; the President's new nominee for the position recommended <u>suspending the</u> <u>monthly reports</u>.
- There is continuing news about administration/university conflicts and negotiations, including new news about a <u>Brown University</u> settlement and <u>UCLA</u> frozen funds (and a court order unfreezing some of those funds, consistent with an existing preliminary injunction).

## Federal Developments Continued

**Executive Orders** 


August 7, 2025

- "Senior appointees" (defined as political appointees) will review all discretionary grants. They will be held personally responsible for their reviews.
- Discretionary awards must, where applicable, demonstrably advance the President's policy priorities.
   No:
  - "Racial preferences," including "intentional proxies for race."
  - Denial of "sex binary in humans"
  - "illegal immigration"
  - There will be a preference for discretionary awards should be given to institutions with lower indirect cost rates.
- A variety of commitments to "rigorous scholarship" and "achieving Gold Standard Science."
- New Terms and Conditions will allow "termination for convenience, including when the award no longer advances agency priorities."
- "To the maximum extent permitted by law, [agency heads shall] take steps to revise the terms and conditions of existing discretionary grants to permit immediate termination for convenience."

Cut federal taxes


Scale back mandatory programs

Reduce or eliminate discretionary grants

Shrink the federal footprint

# Current activity targets three areas, all of which provide S/L, nonprofit grants





#### Other Mandatory:

- TANF
- SNAP
- Child Nutrition
- SSI
- EITC
- Federal Retirement





#### Reconciliation

- Limited to mandatory programs
- Medicaid, SNAP, student loans, tax policy
- More to come?

#### FY 2026 Budget

- President's budget released in June
- FFIS appropriations tracker discretionary grants:
  - -20% from FY 2025
- Congress advancing individual bills





#### Regular Process

- Can be used for anything: appropriate, authorize, change mandatory and discretionary programs, raise or suspend debt limit, amend Social Security
- Requires bipartisan support because of Senate filibuster (60 votes)

#### Reconciliation

- Powerful but limited in scope
- Can be used only to address mandatory spending (but not Social Security), taxes, and the debt limit
- Expedited process permits up or down vote with simple majority and no Senate filibuster

### Loose ends in FY 2025



#### Unsettled funding outlook

- Funds frozen, paused, cancelled, disappeared
- When finally released, application periods are truncated
- No final allocations for several grants
- In fact, no final funding levels!
- The fiscal year is almost over!
- Don't even ask about 50-state numbers

• Budget is rarely released in February; more often in March

#### **April 15**

Congress seldom adopts a budget resolution

#### **May 15**

 House "deems" top-line discretionary spending, allocates amounts to 12 appropriations subcommittees; House and Senate proceed with different topline amounts

#### October 1

 Fiscal year begins with few or no appropriation bills enacted; a continuing resolution (CR) maintains funding at prior-year levels

#### Sometime after October 1

 House and Senate agree to topline amounts and enact an omnibus/minibus bill that bundles all/several appropriations bills; may include non-budget legislation





#### President's budget

- Topline: FY 2026 budget increases defense discretionary by 13%; cuts non-defense discretionary by
   23%
- 193 grants (\$107B) identified for elimination

#### House

- Topline: Level funding for defense, ~6% cut to nondefense
- Most committee work complete, but early August recess forced a pause

#### Senate

- No topline agreement, but committee is approving bipartisan bills
- More funding compared to House; roughly FY 2025 level

Enacting final appropriations will be a challenge—bipartisan support needed in Senate

## CR likely, shutdown possible



#### Continuing Resolution (CR)

- Enacted on or about October 1 absent full-year appropriations
- Maintains prior-year funding until specified date
- "Clean" CR has no extraneous policy or budget provisions
- Some years have several CRs
- Impedes long-term planning and effective budgeting

#### Shutdown

- Occurs when funding for government operations expires because Congress has failed to enact a budget or CR
- Timing matters: a shutdown at the beginning of a FY usually has fewer negative impacts
- Duration is key: a week or two is manageable; beyond that, things get dicey
- Reimbursement of state spending guaranteed for some programs

## Al screening for words and themes

- Analysis has shown that words associated with themes in issued executive orders and federal agency guidance are being removed or replaced on federal websites.
- Federal agencies may be conducting Al screening for these or similar words in federal grant applications and reporting.
- Applications and reports that omit these words or themes may not trigger additional review.

## Reminders/Best Practices

- Grants with signed agreements appear to be somewhat stable for the time being
- Some grants may be terminated for convenience—check terms and conditions
  - The standard terms and conditions are being amended by EPA to make grants easier to cancel for convenience
  - Stay consistent with terms and conditions
- Get any directives in writing
- Know that calls may be recorded
  - Folks from the federal government and potentially DOGE in particular are joining meetings.
- Reporting and funding applications: anticipate use of AI screening for key words.
- Court cases continue: Covid and FEMA fund cancellations were blocked; reductions in force blocked, then unblocked.
