Background

- On June 25, 2020, Governor Tim Walz and Lieutenant Governor Peggy Flanagan announced a plan to distribute \$841 million from the state's allocation of the federal Coronavirus Relief Fund to support local government coronavirus relief efforts.
- The funding for counties, cities, and towns can be used to support local government services as well as grants to businesses, hospitals, and individuals who have been impacted by COVID-19.
- "Local governments urgently need this funding in order to effectively respond to this unprecedented public health emergency," said Department of Revenue Commissioner Cynthia Bauerly. "The Department of Revenue has a long track record of distributing aid to local governments. The infrastructure already in place will ensure this aid is distributed quickly and accurately."

Expenditure Review Process

- Minnesota Management and Budget Commissioner Myron Frans submitted this proposal to the Legislative Advisory Commission for their review on June 25, 2020. All members submitted recommendations, and Commissioner Frans issued the order approving this request on June 26, 2020. The Department of Revenue began distributing the funds on a rolling basis beginning the week of June 29, 2020. Any remaining unspent funding must be returned to the state by December 10, 2020. The state must also recoup money if local governments are found to have spent the aid improperly.

Distribution Methodology

- The Minnesota Department of Revenue is distributing the funding to local governments. Local governments will receive a direct payment based on the per capita formula developed by the state legislature during special session.
- Prior to distributing the aid, local governments must certify their intent to follow [federal guidelines for the use of funds received](#). The CARES Act requires that payments may only be used to cover costs that are necessary expenditures incurred due to the public health emergency; were not accounted for in the budget most recently approved for the state or local government; and were incurred during the period that begins on March 1, 2020, and ends on December 30, 2020. Cities and towns must incur costs by November 15, 2020 and counties must incur costs by December 1, 2020.

Distributions

The Department of Revenue received and approved certifications for 85 counties, and 1,530 cities and townships through the September 15, 2020 certification period. The total amount distributed was \$837,728,966.
