### Office of the Foster Youth Ombudsperson

#### AT A GLANCE

- Office of the Foster Youth Ombudsperson (OOFY) is available to serve any of the 12,000+ current or recent Minnesota foster youth.
- The first Ombudsperson was hired in October 2023, OOFY hired an additional 3 staff in 2024.
- 50 people have contacted OOFY within approximately 3 months of opening.

#### PURPOSE

The Office of the Foster Youth Ombudsperson (OOFY) was created during the 2022 legislative session through advocacy of people with lived experience in foster care. OOFY is a neutral and independent agency whose purpose is to promote the highest attainable standards of competence, efficiency, and justice for foster youth. OOFY hears from foster youth around the state and seeks to elevate their concerns and work towards resolution. If appropriate, OOFY may choose to conduct investigations, write reports to the Governor or legislature, or make recommendations for both individual and systems-level change. In alignment with the One Minnesota Plan (<u>https://mn.gov/mmb-stat/one-mn-plan/One-MN-Plan-Building-Blocks.pdf</u>), OOFY has spent their first months engaging with stakeholders to ensure clear understanding of OOFY's mandate and approach and prevent duplication of roles.

Since the Ombudsperson's hiring in October of 2023, the agency has:

- 1. Hired three staff, for a total of four full-time employees.
- 2. Made progress on setting up infrastructure, including data collection system, website, and office.
- 3. Begun to hold meetings with their Advisory Board.
- 4. Conducted outreach with foster youth in different settings, county and state agencies, community organizations, and other stakeholders.
- 5. Opened to take requests for assistance from foster youth and their supporters.

#### BUDGET

As a newly established office, OOFY does not have detailed historical spending. OOFY has a general fund appropriation base of \$759 thousand in fiscal year 2025 and beyond. For the first fiscal year, OOFY's funds have primarily been spent on staff compensation and infrastructure set-up, with some funds being used for training and community engagement opportunities.

#### STRATEGIES

The Office of the Foster Youth Ombudsperson promotes the highest attainable standards of competence, efficiency, and justice for foster youth through the following strategies:

- **Receiving, Investigating, and Resolving Complaints**: Provides an impartial and unbiased process for foster youth to share concerns about facilities, foster homes, agencies, people, actions, or policies and have them investigated.
- **Providing Oversight and Closing Gaps:** Minnesota's foster care system is county-run and it can be difficult for young people to identify the right avenues to escalate concerns. OOFY may bridge communication between foster youth, local agencies, and/or the Department of Human Services or the Department of Children, Youth, and Families so that all foster youth have access to a high-quality care.
- **Promoting Competence, Efficiency, and Justice**: The Ombudsperson independently draws conclusions, examines existing policies and procedures, identifies opportunities for raising overall

standards, makes recommendations, and produces reports aimed at improving the foster care system.

- **Providing Information:** OOFY provides engagement, education, and information to foster youth, their loved ones, child welfare staff, and the community.
- **Promoting Equity:** People of color and LGBTQ2S+ youth are disproportionately represented in our foster care system. Addressing both individual and systemic concerns advances equity and provides for greater accountability and transparency in improving inequitable systems.

#### RESULTS

A central focus for OOFY is receiving, investigating, and resolving complaints from foster youth and others. Complaints may require various levels of resolution, ranging from referral to investigation. OOFY is able to support systems-level improvements through publication of research and reports, informed through our direct outreach and engagement with foster youth.
