AT A GLANCE

- The Minnesota Department of Veterans Affairs serves more than 285,000 Veterans and their families. This number represents about 6% of Minnesota's population
- Employs approximately 1,620 staff statewide
- The Agency operates eight State Veterans Homes and four State Veterans Cemeteries
- To meet the needs of Minnesota's Veterans, MDVA operates seven major program areas in two divisions. Each program area encompasses many additional Veteran services:
 - Skilled Nursing and Domiciliary care
 - Adult Day Center and Resources for Caregivers
 - Veteran Suicide Prevention and Awareness as well as a Community Health Navigator Program
 - Veterans Education and Occupational Resources
 - Federal Veterans Affairs (VA) Claims and Outreach Services
 - Homeless Veteran Prevention and Assistance Services
 - State Soldiers Assistance Program

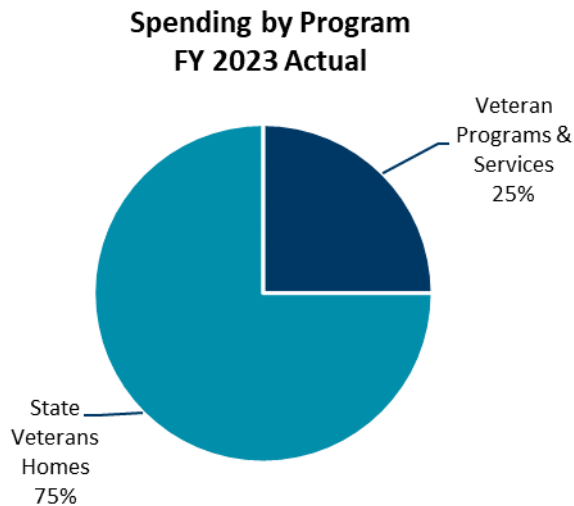
PURPOSE

The Minnesota Department of Veterans Affairs (MDVA) mission is to *"Serve Minnesota Veterans, their dependents and survivors by connecting them with the Federal and State care as well as the benefits they have earned."* Established in 1943, MDVA is a post-war-time agency created to consolidate Veteran programs and services for service members. Since 2007, MDVA has also operated the Minnesota State Veterans Homes.

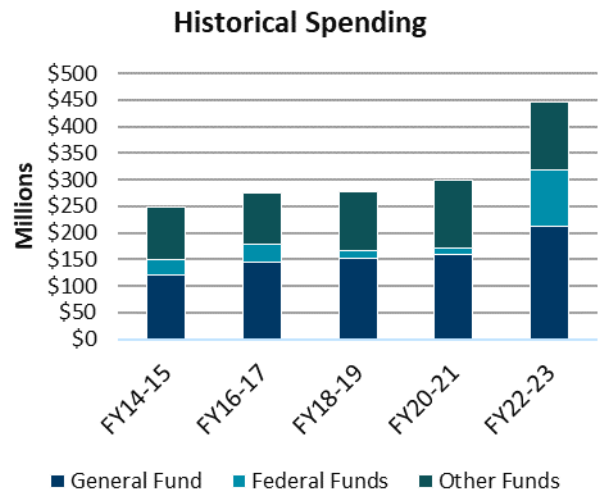
Approximately 41,000 Minnesotans have served since the terrorist attacks on 9/11/01. Veterans from all eras face common as well as unique employment, education, reintegration to society, and health challenges. More than 52% of Minnesota's Veterans are over the age of 65, creating specific, long-term care needs. Veterans from the current conflicts faced multiple deployment, burn pits, and an environment very different from Minnesota. As a result of these conflicts, Veterans may experience short as well as long-term health in addition to mental health challenges, unemployment or underemployment, and complications navigating the Federal Veterans Affairs programs. MDVA's mission is to also care for military/Veteran families. Many of these families faced both mental fatigue and physical injuries associated with multiple deployments of their Veteran loved one.

MDVA's leaders constantly seek opportunities to pioneer programming to meet the unique needs for Minnesota's Veterans and their families. The MDVA goal is to ensure Veterans are provided programs, services, and healthcare to maximize their quality of life in addition to enhance their opportunity to fulfil their desire to become productive Minnesotans.

MDVA operational program activities were funded by approximately 60% from the general fund, 4% from federal funds, and 36% from special revenue funds in the FY 2022-23 biennium. This percentage breakdown does not include \$94 million in Federal Funding for the construction of three new Veterans Homes and one new State Veterans Cemetery. The \$94 million is included in the large increase in federal funds during the FY 2022-23 Biennium in the Historical Spending graph above.

Most of the Programs and Services Division budget is funded by the General Fund. Minnesota's four State Veterans Cemeteries receive burial reimbursements from Federal funding. These funds cover maintenance and development costs. MDVA also receives Federal reimbursement to approve and certify programs in Minnesota's Higher Education institutions so Veterans along with their families can access the Federal GI Bill.

The Veterans Healthcare Division is funded through a State General Fund appropriation, Resident maintenance fees, VA per diem, Medicare along with third-party insurance, and other reimbursements. The historical spending graph above reflects the following breakdown:

- A General Fund appropriation of \$133 million in the FY 2022-23 biennium was received and transferred to the MDVA Special Revenue Healthcare Fund as permitted in state statute. The Historical Spending graph above reflects the expenditure of these funds out of the General Fund to show its source of funding.
- An additional \$110 million of receipts was received from the Federal VA for Veterans full as well as partial per diems, Medicare reimbursements for Medicare Part A, B, & D, receipts from Resident maintenance fees, and other miscellaneous reimbursements. The Historical Spending graph above reflects the expenditure of all these funds in the other funds category rather than the federal funds category for Federal per diems and Medicare receipts.

STRATEGIES

MDVA takes pride in offering innovative solutions specifically tailored to enhance the lives of Minnesota's Veterans and their families. Many of these innovative solutions can be seen in our 2023 Annual Report (https://mn.gov/mdva/assets/2023-mdva-annual-report_tcm1066-608988.pdf). Through strategic planning modalities, leaders develop as well as implement programming to meet current, ongoing, and future needs. MDVA does this through two divisions: **Programs & Services** (including Minnesota's four State Veterans Cemeteries) and **Veterans Healthcare** (eight Minnesota State Veterans Homes and support programs).

Many Veterans are not aware of the benefits they earned through their military service. The **Programs & Services Division** collaborates with its partners in the Veterans services community to assist Veterans in accessing these benefits. Examples include securing or assisting in the provision of financial, educational, and medical benefits. Additionally, there are an estimated 200 Veterans without safe, stable or affordable housing on any given night in Minnesota. Through partnerships as well as collaboration with stakeholders and the Homeless Veteran Registry, (<https://mn.gov/mdva/resources/homelessnessandprevention/homelessveteranregistry.jsp>) MDVA strives to identify along with develop housing plans for Veterans who are homeless or at risk of homelessness. To date, Minnesota has achieved the effective end to Veteran homelessness in eight of 10 continuums of care.

MDVA operates four State Veterans Cemeteries (<https://mn.gov/mdva/memorials/>) located in Duluth, Little Falls, Preston and Redwood Falls.

Finally, the Programs & Services Division and partners provide resources to assist Veterans transitioning back to Minnesota, attending higher education, pursuing occupational resources strategies, accessing financial as well as family counseling, and filing federal claims.

The **Veterans Healthcare Division** operates eight Minnesota Veterans Homes located in Bemidji, Fergus Falls, Hastings, Luverne, Minneapolis, Montevideo, Preston, and Silver Bay. The three newest facilities in Bemidji, Montevideo, and Preston opened in early 2024.

MDVA works to ensure Veterans and their families have options for meeting long-term care needs while providing the highest-quality care. The division offers multiple options for Veterans as well as their families including 24-hour skilled nursing, domiciliary, adult day care, and pharmaceutical needs. The division provides specialty care units for Alzheimer's as well as dementia, oral health care initiative, physical rehabilitation, work therapy, transportation, chemical dependency, psychological, spiritual, and recreational services to improve the health along with quality of life of our Residents.

In addition, the Healthcare Division leads a robust effort to reduce Veteran suicide rates in Minnesota and has most recently engaged in strategic planning and program development for a Veteran health navigator program to further connect Veterans with their state and federal benefits when seeking healthcare services in the community.

Recommendation:

The Governor recommends additional funding of \$17.93 million in FY 2026, \$21.25 million in FY 2027 and \$25.68 million in each subsequent year from the general fund to help address operating cost increases in the Health Care Division at the Minnesota Department of Veterans Affairs.

Rationale/Background:

The cost of operations rises each year due to increases in employer-paid health care contributions, FICA and Medicare, along with other salary and compensation-related costs. Other operating costs, like rent and lease, fuel and utilities, and IT and legal services also grow. This cost growth puts pressure on agency operating budgets that remain flat year to year.

Agencies face challenging decisions to manage these rising costs within existing budgets, while maintaining the services Minnesotans expect. From year to year, agencies find ways to become more efficient with existing resources. For the Minnesota Department of Veterans Affairs, the following efficiencies have been implemented to help offset rising operating costs:

- The Minnesota Department of Veterans Affairs has engaged in information technology solutions to enhance the stakeholder and client experience. These solutions generate an efficient, streamlined process for applicants to apply for earned benefits, receive timely status notifications, and decisions on their claim. The process improvement ensures program integrity, and the eligibility criteria is met per statute.
- The Minnesota Department of Veterans Affairs has also prioritized hiring of staff at Minnesota Veterans homes and greatly reduced the use of costly supplemental contract staffing pools. Additionally, the Health Care Division has worked to reduce costs and optimize existing ancillary service contracts.

For FY 2026-27, agencies will need to continue to find additional efficiencies and leverage management tools to help address budget pressures. Holding open vacancies in certain programs or delaying hiring in other programs are examples of ways agencies manage through constrained operating budgets. Such decisions are difficult and must be weighed against a program’s ability to conduct business with less staffing and its impact to service delivery. Agencies will need additional tools and flexibility, similar to those available in the private sector and other government entities, to help address operating pressures in upcoming biennium.

Without additional resources to address these cost pressures, both in funding and in flexibility to manage internal budgets, services delivered to Minnesotans will be impacted.

Proposal:

The Governor recommends increasing agency operating budgets to support the delivery of current services. For the Minnesota Department of Veterans Affairs, this funding will ensure the eight Minnesota State Veterans Homes in Minneapolis, Silver Bay, Fergus Falls, Luverne, Preston, Montevideo, Bemidji, and Hastings are able to continue operations. This funding will help cover expected growth in employee compensation and insurance, IT services and other operating costs.

Furthermore, this operating adjustment will ensure that an additional \$26 million in Federal VA Per Diems, Resident Maintenance Fees and Medicare Reimbursements will continue to be collected to support the operation of MN State Veterans Homes in the FY 26-27 biennium.

The department is requesting funds to cover compensation costs for 185 FTE’s in FY 2026 and 210 FTE’s in FY 2027. Without this additional funding the department will need to lay-off staff in our Veteran Homes. The impact will be a reduction in service and not permit the hiring of the necessary staff for the new homes to reach the optimal census in the number of beds that are available to care for Veterans and their spouses. We anticipate this to result in a census occupancy of no more than 75% in all MN Veterans Homes, versus the current 90% that we are obligated to be at per federal Veterans Administration regulations. With federal expectations for census coupled with the current MN Veterans Home waiting lists average time of 9 months – 18 months depending on location, Veteran access to care will be negatively impacted causing significant stakeholder feedback and issues with regulatory compliance.

Furthermore, the department is requesting additional funds to support non-salary operating funds to cover expected cost increases for medical supplies & equipment, utilities, resident food, laundry, housekeeping, pharmaceuticals, facility maintenance and other non-salary expenses. In addition, the expected increases in MNIT technology services due to increased compensation costs along with expected rate and usage cost increases are needed to support and maintain the Veterans Homes operations.

The Governor recommends additional funding of \$393,000 in FY 2026 and \$796,000 in each subsequent year from the general fund to help address operating cost increases in the Programs and Services Division at the Minnesota Department of Veterans Affairs.

Rationale/Background:

The cost of operations rises each year due to increases in employer-paid health care contributions, FICA and Medicare, along with other salary and compensation-related costs. Other operating costs, like rent and lease, fuel and utilities, and IT and legal services also grow. This cost growth puts pressure on agency operating budgets that remain flat year to year.

Agencies face challenging decisions to manage these rising costs within existing budgets, while maintaining the services Minnesotans expect. From year to year, agencies find ways to become more efficient with existing resources. For the Minnesota Department of Veterans Affairs, the following efficiencies have been implemented to help offset rising operating costs:

- **Welcome Home Letter (WHL) Process Automation:** Transitioned the WHL process to the Veteran Application Tracking System (VATS)-Salesforce system, automating data entry and letter generation for military service members returning from active duty. This reduces staff time spent on manual data entry and increases efficiency.
- **County Veterans Service Officer (CVSO) Certification Process Automation:** Moved the manual CVSO certification process to VATS-Salesforce, which now collects, validates, and tracks certification requirements automatically. This reduces staff hours and streamlines the certification workflow.
- **Higher Education Veterans Program (HEVP) Travel Audit:** Reviewed operational needs and adjusted travel for the HEVP; conducted a fleet cost analysis resulting the decision to decline month-to-month vehicle lease renewals. The resulting return of two leased vehicles significantly reduces operating costs in FY25 and ongoing, without diminishing services.

For FY 2026-27, agencies will need to continue to find additional efficiencies and leverage management tools to help address budget pressures. Holding open vacancies in certain programs or delaying hiring in other programs are examples of ways agencies manage through constrained operating budgets. Such decisions are difficult and must be weighed against a program’s ability to conduct business with less staffing and its impact to service delivery. Agencies will need additional tools and flexibility, similar to those available in the private sector and other government entities, to help address operating pressures in upcoming biennium.

Without additional resources to address these cost pressures, both in funding and in flexibility to manage internal budgets, services delivered to Minnesotans will be impacted.

Proposal:

The Governor recommends increasing agency operating budgets to support current services. For the Minnesota Department of Veterans Affairs, Programs and Services Division, this funding will help cover expected growth in employee compensation and insurance, IT services and other operating costs.

Recommendation:

The Governor recommends offering discounted hunting and angling licenses to eligible veterans with a service-connected disability rating between 50% and 99% at the reduced cost of \$5 beginning in March 2026. This fee covers the processing costs of the state’s electronic licensing system and ensures the licenses contribute to federal funding allocations for wildlife conservation. This builds on the current program, which offers free licenses to veterans with 100% service-connected disability ratings. It also still preserves Minnesota’s eligibility for federal Pittman-Robertson Wildlife Restoration Act funding.

Rationale/Background:

Across the United States, efforts to increase the use of public lands and outdoor recreation as a treatment for PTSD and other related conditions in Veterans have been gaining increased traction. There are many different non-profits coordinating these efforts for disabled veterans. The United States Congress has also tasked the United States Department of Veterans Affairs Veterans Health Administration (VHA), through the Veterans Comprehensive Prevention, Access to Care, and Treatment (COMPACT) Act of 2020, with establishing a Task Force (Task Force) on Outdoor Recreation for Veterans.

One of the main areas that the Task Force is focusing on is identifying barriers that make it challenging for Veterans to connect with outdoor recreation opportunities that augment their health and wellness. In many instances, the cost of a license can be a barrier for hunting and fishing activities.

This proposal would reduce the cost of license for service-connected disabled Veterans, reduce barriers and create more hunting and angling opportunities for more service-connected disabled veterans.

Proposal:

The Governor recommends expanding eligibility of reduced price (\$5) Deer Firearm, Deer Archery, Deer Muzzleloader, Small Game, and Angling licenses to veterans with a service-connected disability rating between 50% and 99% as defined by the United States Veterans Administration starting in March 2026. This builds on the current program, which offers free licenses to service-connected veterans with 100% disability ratings.

The \$5 fee covers the state’s electronic licensing system processing costs and ensures Minnesota maintains access to the federal Pittman-Robertson Act funding, which is partially based on license sales. The change will result in an annual loss of approximately \$66,000 in revenue in FY 2026 and \$320,000 annually thereafter beginning in FY 2027.

This proposal will impact the families of service-connected disabled veterans, by creating more opportunities for family outdoor recreation and the associated positive outcomes for the veterans connecting with nature. This proposal will also reduce cost barriers to hunting and fishing.

Equity and Inclusion:

Creating new opportunities to connect with nature and reducing cost barriers will have a positive impact on equity and inclusion. In addition to being a protected class, Veterans are representative of a broad cross section of the population, including both metropolitan and Greater Minnesota populations (urban & rural), people with disabilities, Native Americans, Black, Latine/Latinx, African immigrant, Asian American and Pacific Islander (AAPI) and people in the LGBTQIA2S+ communities.

This proposal will directly impact Veteran Minnesota’s Tribal Members. American Indian and Alaskan Native Veterans (AIAN) have one of the highest rates of military service per capita in the country, with 25% of able-bodied, adult AIANs enlisting in the armed forces. They have served in every major conflict involving the United States in the last 200 years.

As with the broader population of Minnesota’s service-connected Veteran population, reducing barriers to outdoor hunting and fishing opportunities off Tribal lands or on lands not held in trust would potentially have mental and physical health benefits for AIANs who experience higher rates of suicide and chronic pain, and who have lower access to mental health services.

- **Suicide Rate:** In 2021, the suicide rate for AIAN veterans was 46.3 per 100,000, the highest of any veteran group.
- **Chronic Pain:** AIAN veterans are more likely to experience chronic pain, especially in their lower back and extremities.
- **Mental Health Services:** Only about a third of AIAN veterans using VA care have access to VA mental health services.

IT Costs

The required changes to the electronic licensing system are minimal and can be handled by the existing staff responsible for system maintenance.

Results:

The intended result of this proposal is that more service-connected disabled veterans will obtain hunting and fishing licenses. This will be tracked in the future if this proposal becomes law and the new license rates and system come online in 2026.

Recommendation:

The Governor recommends updates to Minnesota Statutes §197.6091 to better protect Minnesota Veterans from claims predators.

Rationale/Background:

Governmental Veterans services providers and state leaders of the Congressionally Chartered Veterans Service Organizations (VSOs) which make up the Minnesota Commanders’ Task Force (CTF) are also noting increased activities by for-profit providers offering to file disability benefits claims with the VA for usurious fees or in exchange for an excessive percentage of the benefit secured.

Current Minnesota law (Minn. Stat. §197.6091 Veterans Benefits Services; Disclosure Requirements) requires individuals who offer Veterans benefits services to clients in exchange for compensation— typically private and for-profit providers – provide a written disclosure statement to each client or prospective client. ‘Veterans benefits services’ are services that a Veteran (or a family member of a Veteran) might reasonably use to obtain Veterans benefits from government entities including federal, state, or counties.

The law requires that the written disclosure statement, developed by the Commissioner of the Minnesota Dept. of Veterans Affairs (MDVA), be offered to a client or prospective client. The disclosure statement serves as a method to notify Veterans that they can receive Veterans benefits services at no cost from nonprofit, federally chartered Veterans Service Organizations (VSOs), and MDVA and Minnesota County Veterans Service Officers (CVSOs), with the mandate that a signature by the client confirming their receipt and understanding be obtained by the private and for-profit provider. Providers who fail to comply with section 197.6091 are subject to a civil penalty up to \$1,000 for each violation.

While this was an important step by the state to help protect Veterans from claims predators, there have been additional steps taken at the federal level that should be incorporated into statute.

Proposal:

The Governor recommends changes to §197.6091. Specifically:

- The addition of a requirement for profit providers to have an accreditation by the Secretary of Veterans Affairs.
- The addition of a requirement for a fee agreement found in United States Code, title 38, chapter 59 and Code of Federal Regulations, title 38, section 14.636, paragraph (g).

- The addition of language that prohibits a guarantee of benefits and updates the penalties section by making a violation an unlawful practice under 325F.69 and violators subject to the remedies provided in 325F.70.

Impact on Children and Families:

Children and families of Veterans will directly benefit financially due to this bill ensuring that their Veteran family member secures Veterans benefits without unfair or fraudulent obligations or fees.

Equity and Inclusion: Veterans are representative of a broad cross section of the population, including both the Seven County Metro and Greater Minnesota populations, people with disabilities, Native Americans, Black, Latine/Latinx, African immigrant, Asian American and Pacific Islander (AAPI) and people in the LGBTQIA2S+ communities. Although this initiative is not specifically seeking to eliminate inequities facing these groups, it will have the benefit of a more consistent approach for those seeking of Veterans benefits and services for Veterans and their families no matter who they select to represent them in the development of Veteran claims.

These statutory changes increases consumer protections without demanding or directing Veterans to the utilization of any particular Veterans service provider.

Recommendation:

The Governor recommends the authorization of a new memorial plaque to the Court of Honor located at the Minnesota State Capitol Complex, recognizing the sacrifices of Gold Star and Blue Star families.

Rationale/Background:

Located at the south end of the Minnesota State Capitol Mall, the Court of Honor is defined by curved walls on either side of the Minnesota WWII Veterans Memorial which display bronze plaques commemorating conflicts and men and women who served and sacrificed in support of our state and nation. These plaques memorialize a wide range of conflicts and individuals, including the Spanish American War, World War Two, the Korean Conflict, a former Military Order of the Purple Heart Commander, the 194th Light Tank Battalion, among others.

Being a ‘Gold Star Family’ is a title no family wants. Initiated during World War I, it distinguished a family who lost a loved one in military service. Today, immediate family members (parent, sibling, spouse, or child) receive a Gold Star from the Department of Defense to honor those who made the ultimate sacrifice.

The Blue Star Family tradition is rich in history and also dates to World War I. When an individual enters uniformed service and joins the military community, some military families choose to display a Blue Star service banner or flag in a window of their home. The ‘Blue Star’ signifies that a loved one is an active-duty service member. This special flag, typically displayed only by military families, is the genesis of “Blue Star Family”, referring to the immediate family of an active-duty service member.

A Gold Star Families and Blue Star Families plaque would be appropriate within the context of the plaques already in the Court.

Proposal:

An approval to fund the design development, solicitation, and eventual production of an approved plaque utilizing community contributions and existing MDVA resources.

Impact on Children and Families:

Honoring Veterans and their family’s sacrifices positively impacts children and families in several meaningful ways:

Instilling Values: Honoring Veterans’ families teaches children important values such as respect, sacrifice, and patriotism. By observing ceremonies and tributes, they learn to appreciate the significance of service to country and the personal sacrifices Veterans make to protect freedom and safety.

Building Family Pride: For families of Veterans, especially children and grandchildren, seeing their loved ones honored fosters a sense of pride and connection to their family’s legacy. It reinforces the importance of their relative's service and the role their family has played in the broader history of their country.

Creating Role Models: Veterans who are publicly honored become role models for children. Seeing Veterans and families treated with respect and admiration encourages young people to look up to them and potentially aspire to similar qualities of courage, commitment, and leadership in their own lives.

Strengthening Community Bonds: Honoring Veterans’ families brings communities together, creating shared experiences for families. It helps children and families feel part of something larger than themselves, fostering a sense of belonging and unity through shared ceremonies and traditions.

Preserving Historical Awareness: Recognizing Veterans ensures that younger generations remain aware of their country’s military history and the role individuals played in it. This helps keep history alive and relevant, ensuring that the sacrifices of previous generations are not forgotten.

Emotional Healing and Closure: For families who have lost Veterans, the act of honoring their loved ones provides emotional support, validation, and closure. It shows children their loss is acknowledged and that their family member’s contributions mattered to others, helping them cope with grief and loss in a healthy way.

Fostering Gratitude and Appreciation: Honoring Veterans teaches children and families to be grateful for the freedoms and security they enjoy. This helps cultivate a culture of appreciation for those who have served, making Veterans feel valued and encouraging future generations to uphold this tradition of respect.

Equity and Inclusion:

Veterans are representative of a broad cross section of the population, including both metropolitan and Greater Minnesota populations (urban & rural), people with disabilities, Native Americans, Black, Latine/Latinx, African immigrant, Asian American and Pacific Islander (AAPI) and people in the LGBTQIA2S+ communities. This initiative is not specifically sought to eliminate inequities facing these groups but providing a memorial to family sacrifices offers benefits to the entire Veteran population.

PURPOSE AND CONTEXT

The mission of the Programs and Services Division is to meet the needs of Minnesota Veterans and their families by providing proven and innovative programs and services, helping to maximize their quality of life, and providing final resting places that commemorate their service as well as honor their sacrifice to our Nation.

Minnesota is experiencing a continuing demand for services due to both the aging of the Veteran population in addition to because of 21 years of continuous conflict and ongoing military operations worldwide. For example:

- In fiscal year 2023, the Minnesota Department of Veterans Affairs (MDVA) processed 21,723 State and Federal benefits claims actions.
- Burials at our State Veterans Cemeteries averaged 918 interments/inurnments annually between fiscal year 2020 and fiscal year 2024, with 991 total in fiscal year 2024.
- The State Soldiers Assistance Program assisted 1,255 Veterans and family members, while also providing CORE services to 3,686 individuals in fiscal year 24.
- The Veterans Stable Housing Initiative continues to lead the effort to end Veteran homelessness in the State and has received confirmation from the United States Interagency Council on Homelessness (USICH) of having effectively ended Veteran homelessness in eight of the state's 10 Continuums of Care (comprising 85 of the state's 87 counties).
- The Minnesota GI Bill provided education funding to 1,639 Veterans and family members in 2021.

The Federal VA-estimated Veteran population in the State of Minnesota is 285,000 in 2023. With an end to major military operations related to the Global War on Terrorism and the estimated 47,081 Minnesota Veterans who served during that period, MDVA stands ready to meet Veterans' needs as they continue to return to Minnesota. Many Veterans return with visible combat injuries such as amputated limbs, while many more carry invisible wounds such as traumatic brain injury and post-traumatic stress disorder. MDVA helps them meet their needs by providing assistance including support in accessing their higher education, medical, and financial assistance benefits. The Programs & Services Division also works to identify gaps in programming and services which may

exist in the Veterans services community. It then addresses those shortcomings by providing innovative, Veteran-focused services to Minnesota Veterans, their dependents, and survivors.

Calendar year 2024 includes the following initiatives:

- **“Functional Zero” for Veteran Homelessness**

Goal: Minnesota seeks to be the fourth state in the nation—joining Connecticut, Delaware, and Virginia—to end Veteran homelessness by reaching functional zero for homeless Veterans statewide. In Minnesota, 85 of 87 counties in the state have reached this milestone. The remaining two counties, comprising Minnesota’s most populous areas, will require significant effort and resources to reach the final threshold.

- **Post 9/11 Service Bonus**

Goal: Minnesota seeks to honor its Post-9/11 Veterans by providing bonus payments to Minnesota Veterans of the Global War on Terrorism, as it has done for every war since World War I. MDVA was appropriated \$24.88M for this purpose during the 2022 legislative session and strived to provide bonus payments to the estimated 47,081 eligible Veterans. As in the past, we believe this connection will spur more awareness of State as well as Federal benefits to this newest group of Veterans and allow MDVA to effectively outreach to them.

- **Consolidation of Veteran Information Systems**

Goal: Continued development of our Veterans Application Tracking System (VATS) to further consolidate all MDVA Veterans information management systems into one database which will provide for better lifetime case management, electronic submissions, improved reporting, and reduction of stand-alone systems.

- **Full Operational Capability for the SOAR Team**

Goal: MDVA’s Veteran Supplemental Security Income/Social Security Disability Insurance (SSI/SSDI), Outreach, Access, and Recovery (SOAR) Program is a critical part of our strategy to prevent Veteran homelessness by assisting Veterans and former service members including their spouses as well as dependents with obtaining Federal benefits through the Social Security Administration. Full staffing for the first time in the program’s history resulted in the achievement of full operational capability in addition to effectiveness by realizing more than double the number of referrals to the program in fiscal year 2024 as well as demonstrated the ability to action every one of those referrals, significantly increasing the program’s impact on at-risk Veterans and their families.

SERVICES PROVIDED

- **Claims and Field Operations** (<https://mn.gov/mdva/resources/healthdisability/>) staff represent as Federally Accredited Representatives (Power of Attorney for VA purposes) Veterans in addition to their family members by acting as their advocate in matters pertaining to the U.S. Department of Veterans Affairs (VA) as well as State of Minnesota benefits and entitlements. This division consists of the St. Paul & Fargo (East & West) Federal Regional Office Claims offices, the Gold Star Families as well as Women’s Program, Tribal Veterans Service Officers, Incarcerated Veterans Program, County Veteran Services Education Division, Medical Operations including Veterans Affairs Medical Center’s (VAMC) as well as MDVA Veteran Homes Staffing, and Veterans Outreach.
- **Veterans Employment and Occupational Resources Division** (<https://mn.gov/mdva/resources/education/>) Assists Veterans along with eligible family members navigate the complicated higher educational benefits system while promoting employment and self-sufficiency for those individuals. This division includes the Higher Education Veterans Program (Veterans Campus Representatives) including the State Approving

Agency. It also administers the Minnesota GI Bill and Veterans Employment Preference along with Veteran Owned Small Business as well as Veteran hiring initiatives.

- **Memorial Affairs Division** (<https://mn.gov/mdva/memorials/>) ensures that Veterans along with their families receive the honor they deserve with final resting places of national significance as well as lasting tributes commemorating their service and sacrifice. The division operates Veterans cemeteries at four statewide locations: Little Falls, Preston, Duluth, and Redwood Falls, as well as oversees the Military Funeral Honors Stipend Program in addition to the Bronze Star Marker Program. Through the provision of dignified burial services, upkeep of sacred resting places, and facilitation of commemorative events, the division preserves the memory as well as the legacy of those who have served our country with honor along with valor.
- **State Veterans Benefits Division** (<https://mn.gov/mdva/resources/familyassistance/>) provides programs as well as services unique to Minnesota's Veterans including managing the State Soldiers Assistance Program (SSAP) and Minnesota Service CORE.
- **State Veterans Programs Division** (<https://mn.gov/mdva/resources/homelessnessandprevention/>) Assists Veterans, eligible former service members along with their family members, who are residents of Minnesota, to access applicable Federal as well as State Veterans programs including:
 - The Veteran SOAR Program, which assists Veterans, former service members and Veterans along with former service members spouses as well as dependents with obtaining Federal benefits through the Social Security Administration.
 - The Veterans Stable Housing Initiative, which administers the Minnesota Homeless Veteran Registry (HVR) in addition to providing resources as well as support to assist at-risk Veterans and former service members. They also assist Veterans and former service members experiencing homelessness in obtaining or maintaining stable housing as well as preventing homelessness where possible.
 - The Minnesota Operation for Veterans Empowerment (MOVE) program, which temporarily assists homeless Veterans with one-on-one case management regarding eligible resource availability to empower them to move beyond their current situation and a paid bed at the Union Gospel Mission (St Paul).
- **The MDVA Grant Programs** is housed in Central Office to provide funding for stakeholders and partners who assist MDVA in achieving the agency's mission.
 - **Veterans Service Organizations (VSO) Grants** are provided to Congressionally Chartered Veterans Service Organizations (excluding The American Legion) in Minnesota to assist Veterans along with their families receive the Federal, State, and local benefits they are entitled to receive.
 - **County Veterans Service Officers (CVSO) Grants** provide Minnesota's 87 counties with funding for combat Veteran reintegration; to collaborate with social service agencies, educational institutions, and other community organizations to enhance services offered to Veterans; reduce homelessness; and to enhance the operations of the County Veterans Service Office (<http://macvso.org>).
 - **Minnesota Assistance Council for Veterans (MACV)** (<http://mac-v.org>) is funded through a grant from MDVA that provides assistance throughout Minnesota to Veterans and their families who are homeless or in danger of homelessness.
 - **Support our Troops (SOT) Grants** (<https://mn.gov/mdva/resources/supporttroopslicenseplates.jsp>) are competitive grants provided to eligible foundations along with other organizations approved by the Commissioner, whose purpose is supporting as well as improving the lives of Veterans and their families. These grants are funded through the Support Our Troops License Plate Account.

MDVA partners with the VA, VSOs, CVSOs, the MACV, and other organizations to provide benefits and services to Veterans. Additionally, MDVA partners with several state agencies to accomplish its work.

PURPOSE AND CONTEXT

The first Minnesota Veterans Home was established in 1887 in Minneapolis as the Minnesota Soldiers Home to “reward the brave and deserving.” This Soldiers Home in Minneapolis was not primarily designed as a skilled nursing facility, but as the needs of Veterans changed, so too have the Veterans Homes. In the 1960s, Minnesota started shifting its primary focus to meet the healthcare needs of Veteran Residents in the Federal Veterans Administration State Veterans Home program. Today, the Minnesota Department of Veteran’s Affairs (MDVA) operates eight Veterans Homes located in Bemidji, Fergus Falls, Hastings, Luverne, Minneapolis, Montevideo, Preston, and Silver Bay; and one Adult Day Care program located in Minneapolis.

Healthcare Division initiatives are reviewed annually to ensure both quality care and operational excellence are achieved in all Veteran Homes. The initiatives detailed below were developed with staff as well as stakeholder input. The Veteran Homes were the primary focus in fiscal year 2023, including agency-level policy and procedures. Our goal is to always provide quality Resident care outcomes in state-of-the-art facilities with the highest level of efficiency. Many stakeholder groups are engaged in our Division performance, and we strive to align with both State and Federal goals impacting aging Veterans. The MDVA Healthcare Division’s goal is to ensure all healthcare facilities and programs are coordinating as one agency providing the highest level of care. In addition to the initiatives noted below, a primary focus of this past year was to stabilize the Healthcare Division, ensuring the growth of three new facilities is incorporated into the overall organizational structure. An additional focus area is to redesign an organizational chart that ensures continuity of services during transitions and succession planning.

Calendar year 2023 included the following initiatives (not an inclusive list but highlights of top priorities):

1. COVID-19 Pandemic Emergency Response Transition

Goal: Under the guidance of MDVA Healthcare senior leaders, each facility continues to refine an Infection Prevention (IP) strategy which includes the latest guidance from CMS, the Minnesota Department of Health (MDH), Centers for Disease Control and Prevention (CDC), and Department of Labor and Industry (DOLI). This allows all facilities to minimize the negative effects of all infectious diseases, including COVID-19, and follow

an operational plan that monitors the impacts to a community, minimizes emergency response during outbreak, and continues to provide the highest quality of care.

2. Clinical Education/Best Practice – End of Life Care Education Program

Goal: Enhance all areas of palliative care, advance care planning, and hospice in all Veterans Homes to provide Residents with dignity at end of life. Continue to offer as well as lead in clinical training programs to improve and enhance the quality of care delivered to Residents specifically during end of life along with prepare to meet the new healthcare needs of our current aging Veteran population.

3. Three New MN Veterans Homes

Goal: Successfully open the three new Minnesota Veterans Homes and achieve federal VA recognition. All Homes have successfully opened, admitted their first Residents, and achieved Federal VA recognition. Homes will be at 75% occupancy by end of fiscal year 2025. Going forward, a primary focus will be efforts to continue to recruit and hire, in addition to admitting Residents along with ensuring that quality of care remains excellent.

4. Healthcare Operations

Goal: Maximize revenues available through all possible means available to include federal VA per diem, Medicare, insurance, and Medicare Part D. Reviews of all Resident reimbursement options are ongoing. Primary areas of focus have been census realignment along with maximization, a comprehensive Healthcare Division recruitment as well as retention strategy, and an intentional collaboration of the admissions process, ensuring that all Veterans maximize their available benefits. In addition, a review of Minnesota Administrative Rule 9050 with recommended revisions will be completed this year.

5. Domiciliary Program Quality of Care

Goal: MDVA facilitated a Quality-of-Care workgroup to evaluate Resident/Veteran care needs, staffing requirements, and program enhancements to further improve the care delivery model. In addition, State funding was received for the Hastings campus as well as design work is in progress as we wait for a decision from the Federal VA State Construction Grant Program.

6. Veteran Suicide Prevention and Awareness.

Goal: MDVA continues working to reduce Veteran suicide rates in Minnesota. Current data shows approximately 100 Veterans die by suicide annually in Minnesota. MDVA leads the Minnesota Veteran Suicide Prevention and Awareness Collaborative (formerly called the “Governor’s Challenge to Reduce Veteran Suicide”). MDVA is actively partnering with the Minnesota Department of Health, the Federal VA, Minnesota Army National Guard, County Veteran Service Officers, Veterans Service Organizations, and other community partners on this effort.

7. Veteran Health Navigator Program

Goal: MDVA has begun strategic planning and development of the Veteran Health Navigator program. The program targets active military and Veterans, connecting them to Veteran resources at all levels (community, State, and Federal), engaging them in preventive care as well as assisting with management in care coordination programs. MDVA is actively working with the Minnesota Department Health’s Office of Rural Health & Primary Care, Health Care Homes, Minnesota Hospital Association, and the Federal VA systems on best practices, building key metrics, as well as evaluating healthcare systems on readiness to implement a Navigator Program.

SERVICES PROVIDED

MDVA provides care designed and delivered according to the individual needs of the Resident (Resident Centered Care). All MDVA State Veterans Homes have the goal of restoring, optimizing, and/or maintaining each Resident's level of function, personal autonomy, and dignity as well as recognizing the individual's service to the country.

The following programs and services are offered in each Veterans Home:

- Specialty care units for those diagnosed with dementia
- Rehabilitation services – including occupational, speech, physical therapy, and general physical fitness
- Social services, recreational therapy and behavioral services
- Coordination of specialty appointments with outside providers
- Life enhancement activities – Entertainment, games and outdoor activities
- Drug and alcohol supportive services
- Vocational rehabilitation
- On-site specialty services – dental, ophthalmology, audiology, podiatry
- Primary Care and some Specialty Care

In recent years, the Healthcare Division senior leadership team, with a strong commitment to Veteran-centric care, has focused primarily on the transition from the COVID-19 pandemic emergency response to the construction and opening of three new Minnesota Veterans Homes. Minnesota was the first state in the country to ever open three new Veterans Homes at one time. The accomplishment required the leadership team to provide frequent and onsite support to ensure successful openings along with meeting regulatory requirements.

To optimally manage operations and ensure a high-quality experience across the system for both Residents and staff, the following initiatives have been a priority:

- Enhancement of Resident-centered care and family-centered care models at all Veterans Homes to meet the unique individualized care of Veterans and their families.
- Clinical care advancements to include innovative programming that cares for Veterans with dementia diagnoses, addressing complex medical and behavioral health needs.
- Implementation of a Healthcare Division Recruitment and Retention strategy to include seven different focus areas to attract new talent and improve the employee experience.
 - Retention efforts focused on leadership and clinical training program as well as individualized development plans.
 - Recruitment includes the recruitment of staff to: open three new Veterans Homes in greater Minnesota, reduce supplemental staffing from all homes, and begin a recovery strategy from pandemic impacts to staffing.
 - The Healthcare Division Employee Wellness Initiative focused on enhancing the enterprise-provided wellness resources to support the unique stressors of the Healthcare worker experience.
- Asset preservation, repair, and betterment funding as an ongoing necessity to extend the useful life as well as maintain aging facilities at all locations.
- The eight Minnesota Veterans Homes continue to make facility refinements for the long-term health of the facilities. Hastings is in process of a total campus redesign, with the goal of single rooms with private bathrooms, pending Federal VA funding.
- Compliance with CMS standards for the purpose of enhancing the level of care provided at the Veterans Homes and generating an opportunity to bill services to all available sources.
- By hiring a Director of Community Health to lead the Veteran Suicide Prevention and Awareness program along with to develop as well as implement a new Veterans Health Navigator program.

RESULTS

The Minnesota Veterans Homes provide a community environment for Veterans along with their families that promotes respect and dignity in addition to mental, physical, and spiritual well-being. Providing enhanced mental health and chemical dependency training as dedicated professionals, our staff can promote along with support transitioning Domiciliary Residents back to their communities. The key measures include customer satisfaction, staff turnover, and the prevalence of citations or recommendations from the Minnesota Department of Health, the Federal Department of Veteran Affairs, as well as CMS.

Narrative

Department of Veterans Affairs (VA) - Construction Grants for State Cemeteries

This grant funded project (FAI: MN-21-09) will fund the installation of pre-placed crypts and construction of landscaping, irrigation and supporting infrastructure in the Minnesota State Cemetery in Little Falls. The project will develop approximately 1.2 acres. The construction will include 742 pre-placed crypts. The estimated total cost of the project is \$1,368,000. The department already received approval of the use of these grant funds from the Legislative Advisory Commission in March of 2024.

MDVA agrees that upon completion of the project, it will provide adequate financial support and a trained workforce to maintain and operate the cemetery in accordance with National Cemetery Administration standards. MDVA agrees that it will operate the cemetery solely for the interment of veterans, their spouses, surviving spouses, minor children, unmarried adult children who were physically or mentally disabled and incapable of self-support, and eligible parents of certain deceased service members.

Department of Veterans Affairs (VA) - Construction Grants for State Veterans Homes

The MN Department of Veterans Affairs is currently requesting federal grant funds for a replacement bed project to update the Veterans Home in Hastings. The Federal VA's construction grant program for State Veterans Homes requires the State to provide 35% of the funding for the predesign, design and construction of a new Home or remodel of an existing one. During the 2022 MN Legislative Session, state funds were allocated to the design, reconstruct, and update the Hastings Veterans Home. All requirements at this time have been met by the MDVA and the State of Minnesota to be considered for this project, however at this time the agency hasn't received notice of approval of these federal funds to move forward with the project.

Other Federal Funds

The department also receives operational funding reimbursements from the Department of Veterans Affairs (VA) for the following programs that are not reported above as they are not required per MS 3.3005. The MDVA Commissioner is authorized to accept these federal funds per MS 196.053. In FY24 the department received other federal funds as shown below which it expects to continue to receive in FY 2026-27 and beyond.

- 1) State Veterans Homes Per Diem's for care of Veterans = \$43,391,499
- 2) State Veterans Homes Medicare A, B, and D for care of Veterans = \$3,340,462
- 3) State Cemeteries Plot Allowance for Veteran burials = \$603,451
- 4) State Approving Agency Program for Federal GI Bill educational compliance = \$464,916
