Executive Summary

- The COVID-19 Minnesota fund was created to pay expenditures associated with the peacetime emergency declared by the Governor in executive order 20-01 related to COVID-19. The fund was established on March 28, 2020 with a starting balance of \$200 million.
- Money in the fund is appropriated to the Commissioner of Management and Budget to be disbursed or transferred to state agencies, as necessary, to:
 1. Protect Minnesota citizens from the COVID-19 outbreak, and;
 2. Maintain state government operations throughout the duration of the peacetime emergency.
- The Commissioner of Management and Budget may authorize expenditures of \$1 million or less. An expenditure request in excess of \$1 million must be submitted to the Legislative COVID-19 Response Commission for review and recommendation before it can be authorized.
- The COVID-19 Minnesota fund will expire December 31, 2020, pursuant to [Laws 2020, Chapter 81](#). Upon expiration, any money in the fund that remains unobligated will transfer back to the general fund.
- As of December 14, \$28.137 million remains unauthorized in the fund. \$179.746 million has been authorized by the Legislative COVID-19 Response Commission and \$10.684 million has been authorized as an expenditure of \$1 million or less.
- Two expenditure requests totaling \$6,400,000 were submitted to the Legislative COVID-19 Response Commission for review and recommendation between November 30, 2020 and December 14, 2020. These authorizations will provide redeployment of state employees for COVID response and State Emergency Operations Center staffing support.
- Two expenditures of \$1 million or less, totaling \$578,000, were authorized between November 30, 2020 and December 14, 2020.
- Payments from Mayo and the University of Minnesota were received in December, totaling \$18,440,000. These insurance reimbursements were collected from payers as part of the contractual arrangement to provide COVID-19 test processing on behalf of Minnesotans.
- LCRC Action Order #8 provides for discretionary spending on critical supplies. As of December 14, 2020, \$8.032 million of spending authority remains in this authorization. This amount increased from the last report due to the receipt of a refund. No purchases were authorized from LCRC Action Order #8 between November 30, 2020 and December 14, 2020.

Background

The COVID-19 pandemic presented an unprecedented challenge to our State. On March 19, 2020, in a letter to the leaders of the Minnesota Senate and House of Representatives, Governor Walz and Lt. Governor Flanagan asked the Legislature to create a fund that would give the Administration the flexibility to deploy resources necessary to respond to the needs of Minnesotans in real time.

On March 28, 2020, the Legislature passed legislation creating the COVID-19 Minnesota fund, transferring to it \$200 million from the general fund, and appropriating all money to the Commissioner of Management and Budget to be disbursed or transferred to state agencies, as necessary, to:

1. Protect Minnesota citizens from the COVID-19 outbreak, and;
2. Maintain state government operations throughout the duration of the peacetime emergency.

The legislation also established the Legislative COVID-19 Response Commission to review expenditures. Members of the Commission are: Senate President Jeremy Miller, Senate Majority Leader Paul Gazelka, Senate Minority Leader Susan Kent, Senator Julie Rosen, Senator Dick Cohen, Speaker of the House Melissa Hortman, House Majority Leader Ryan Winkler, House Minority Leader Kurt Daudt, Representative Lyndon Carlson, and Representative Pat Garofalo.

The Commissioner of Management and Budget may authorize expenditures of \$1 million or less. However, the process for approving these requests adopted by the Administration requires additional approval from the Commissioner of Health and the Governor's Chief of Staff.

An expenditure request in excess of \$1 million must be submitted to the Legislative COVID-19 Response Commission for review and recommendation before it can be authorized. Upon submission, the Commission has 24 hours to review a request and provide a positive recommendation, a negative recommendation, or no recommendation. If a majority of commission members from the Senate and a majority of commission members from the House of Representatives provide a negative recommendation on a proposed expenditure, the commissioner is prohibited from expending the money. If a majority of the commission members from the senate or a majority of the commission members from the house of representatives do not make a negative recommendation, or if the commission makes no recommendation, the commissioner may expend the money.

The Commissioner of Management and Budget must provide reports on the spending from the COVID-19 Minnesota fund to the Legislative COVID-19 Response Commission on the 15th and last day of each month. The report must include the total amount of each expenditure, the purpose of each expenditure, and any additional information the commissioner of management and budget determines is necessary to properly document each expenditure.

The COVID-19 Minnesota fund will expire December 31, 2020, pursuant [Laws 2020, Chapter 81](#). Upon expiration, any money in the fund that remains unobligated will transfer back to the general fund.

Authorized Expenditures

Below is a summary of total authorized expenditures from the COVID-19 Minnesota fund. The first chart highlights authorized expenditures in excess of \$1 million. The second chart highlights authorized expenditures of \$1 million or less.

Commentary on Authorized Expenditures

Two new LCRC requests was authorized for expenditures in excess of \$1 million between November 30, 2020 and December 14, 2020, totaling \$6.4 million.

- **\$4,200,000 is authorized to the Minnesota Department of Health (MDH) for redeployment of state employees for COVID response.** MDH has reassigned over 900 staff to work part-time or full-time on COVID response. Over 200 MDH staff and state agency staff are supporting the work of the State Emergency Operations Center (SEOC). New COVID-19 positive cases and the demand for testing continue to increase week over week and at levels that are overwhelming our current response staffing capacity. The Governor's Office recently asked agency commissioners to assist the SEOC with finding additional staff to support the response both at the SEOC and MDH. Many staff who will be redeployed are currently being paid from dedicated funding sources, like the Trunk Highway Fund or Environmental Funds. This request will allow redeployments to occur without concern for funding streams. Staff made available through this redeployment will support work both at the SEOC (including assistance in managing and staffing testing events, providing data and other support across all work groups) and at MDH (including assistance with case intake, data analysis, and case investigation).
- **\$2,200,000 is authorized at the Minnesota Department of Health (MDH) to support key positions at the State Emergency Operations Center (SEOC) through June 2021.** The SEOC is coordinating the response activities of nine state agencies and one inter-governmental organization and is currently using Coronavirus Relief Funds (CRF) to support many staff. CRF funds expire 12/30/2020. COVID-19 Minnesota Funds will allow the SEOC to continue their efforts into June of next year. This funding will support positions that coordinate our overall testing strategy in the community and with long term care; coordinate specific testing events both on-site and off-site; provide financial, contracting, and administrative support to the SEOC teams; provide data coordination and analysis to the SEOC teams; and coordinate our vaccine distribution strategy across work groups and agencies. MDH may transfer funds to other agencies providing staff to support the work of the SEOC.

Two new requests were authorized for expenditure of \$1 million or less between November 30, 2020 and December 14, 2020 for \$578,000.

- **\$526,000 is authorized to the Minnesota Department of Health to support a Statewide Healthcare Medical Patient Placement Center.** Since late June, MHealth Fairview has been running the Critical Care Command Center (C4) to monitor ICU bed availability in the state and helping to place adult patients in need of ICU beds when facilities have capacity challenges. With rising COVID case numbers there has been significant interest in having MHealth expand this work to include medical/surgical patients. Funding will allow the C4 to manage the placement of adult medical patients in medical/surgical beds across the system. C4 would be able to assist not only placing patients at higher levels of care but also identify regional and community sites with open beds able to take patients back. Funding may also be used to build out the system to identify available transportation within the system.
- **\$52,000 is authorized to the Minnesota Department of Public Safety to conduct seasonal COVID screening for exam customers.** The Driver and Vehicle Services (DVS) division has established procedures for the screening of knowledge and road test applicants. This procedure includes a health questionnaire and temperature check of each customer who enters the exam station. To date, this

process has been performed at/near the entrances to the stations – sometimes in entryways and sometimes outside the facility under the protection of small tents. Multiple DVS exam stations are not large enough to allow applicant screening and check-ins to be moved completely indoors during the winter months. This funding allows DVS to provide six temporary, enclosed heated shelters to safely screen and check-in customers before they enter the exam station.

Minnesota Department of Health (MDH) has reassigned over 900 staff to work part-time or full-time on COVID response. Over 200 MDH staff and state agency staff are supporting the work of the State Emergency Operations Center (SEOC). New COVID-19 positive cases and the demand for testing continue to increase week over week and at levels that are overwhelming our current response staffing capacity. MDH has previously requested CRF funding to support case investigation work--one of our more labor intensive efforts in the response. While we accurately projected the growth in the state's testing capacity, we did not anticipate the growth we are currently experiencing in test positivity. Test positivity has increased from 5% to 15.4% in just six weeks. We are not able to meet the staffing needs to respond to the level of case growth we are seeing.

The Governor's Office recently asked agency commissioners to assist the SEOC with finding additional staff to support the response both at the SEOC and MDH. Many staff who will be redeployed are currently being paid from dedicated funding sources, like the Trunk Highway Fund or Environmental Funds. This request will allow redeployments to occur without concern for funding streams.

Staff made available through this redeployment will support work both at the SEOC (including assistance in managing and staffing testing events, providing data and other support across all work groups) and at MDH (including assistance with case intake, data analysis, and case investigation).

The state's pandemic response has been operating under a unified command with the State Emergency Operations Center (SEOC) coordinating federal, state and local response efforts.

The SEOC is coordinating the response activities of 9 state agencies and one inter-governmental organization. While the SEOC has a small, dedicated staff complement to manage emergencies, every time the SEOC is activated, staff from other state agencies are called upon to help manage the response. Typically, the SEOC is activated to manage disasters, and staffing is short-term. The pandemic response has been the longest activation of the SEOC, and the cross agency coordination will need to continue. Currently there are over 200 staff from multiple state agencies supporting the work of the SEOC:

- Statewide Health Care Coalition and health care facility staffing and bed capacity
- Critical Care Supplies
- Testing --community and long-term care

This request will support key positions at the SEOC into next year. We are currently using Coronavirus Relief Funds to support many staff. Those funds expire 12/30/2020. COVID-19 Minnesota Funds will allow us to continue our efforts into June of next year.

Funding will support positions that coordinate our overall testing strategy in the community and with long term care; coordinate specific testing events both on-site and off-site; provide financial, contracting, and administrative support to the SEOC teams, provide data coordination and analysis to the SEOC teams, and coordinate our vaccine distribution strategy across work groups and agencies.

MDH may transfer funds to other agencies providing staff to support the work of the SEOC.
