We are requesting a recommendation from the LAC on the following request:

#### Transfer from the General Fund Contingent Account in FY 2025

**Amount** 

To: Department of Administration – Funeral, Memorial, Burial, and Home \$100,000 Repair and Clean Up Expenses Related to Attacks on State Officials

On Saturday, June 14, Speaker Emerita Melissa Hortman and her husband Mark Hortman were tragically assassinated, and Senator John Hoffman and his wife Yvette Hoffman were seriously injured, in an act of political violence.

This transfer is to pay for funeral, memorial, and burial expenses for Speaker Emerita Melissa Hortman and Mark Hortman. This transfer is also available to cover costs related to crime scene clean up and repair at the Hortman and Hoffman homes and property. The transfer is for \$100,000.00 from the General Contingent Account to pay for these expenses.

The state will coordinate to have the General Fund Contingent Account be reimbursed wherever possible from other potential sources.
