**UNIT CLARIFICATION**

**INTRODUCTION**

The State of Minnesota, Bureau of Mediation Services (Bureau), received notices from the State of Minnesota, Minnesota Management and Budget, St. Paul, Minnesota (MMB) between June 26, 2025, and July 17, of sixteen (16) newly created or reassigned positions or classifications.
