

- Select **React** to








- State your name when speaking

Voting results

All recommendations from latest voting: passed

- Revised rec. 61 ("Pass the Model School Response to Drugs and Drug-related Incidents Act.")
- Harm reduction
- Crosscutting
- Data collection
- Combined 4+29 recommendation
- Revised rec. 102 (Steve's law)
- Revised rec. 105 (Naloxone carrying, confiscation)

Prioritization overview

- 116 recommendations approved for legislative report
- Priority recommendations: goal of 20
 - Question: all equal priority, or prioritize within the 20? (To discuss after the priority recommendations have been identified)
- Decision rule:
 - Strong supermajority (75%) as a starting point
 - Expand or refine from there; possibly multiple rounds of voting
- 29 votes per member for first round (25% of 116 recommendations)

Prioritization activity

- 29 votes per member
 - Stickers with your initials, place along edge of the recs you want to prioritize
 - Each member can allocate a maximum of 2 votes to a recommendation
- Mural tutorial and practice
 - Outline, hand/move mode, navigation settings
