



Inpatient Treatment for 30/60/90 Days



**Client Returns** to Treatment (if we/they are lucky)



Client **Graduates &** Discharged from Treatment

Increase Rate of Relapse, Overdose, & Death



**Client Returns** to Previous Unsupportive Living Situation

- Pink Cloud Foundation has received over 5,000 Applications for Housing Assistance from the Recovery Community

## **Client Impact Survey**









My sobriety would have been at risk.

I would have returned to an unsupportive living situation.

I would have had to live in a shelter.







I would have had to live with people who were actively using drugs/alcohol.

I would have been homeless.

I probably would have been actively using drugs and/or alcohol within the first week.




