MNsure serves thousands of Minnesotans who are self-employed, entrepreneurs and small business owners, early retirees who don't yet qualify for Medicare, and those who don't have access to affordable health insurance through their jobs.

The following scenarios use actual 2024 health plans available through MNsure to show how discounts (advanced premium tax credits, or APTC) reduce health insurance costs for individuals and families.

The federal Inflation Reduction Act enhanced these tax credits, meaning larger tax credits are available and more Minnesotans are eligible for these savings. When they shop for health insurance through MNsure, Minnesotans can find a 2024 health plan with premiums that cost no more than 8.5% of their household income, also thanks to the Inflation Reduction Act.


