Thanks for using MNSure. We value your business and look forward to serving you in 2016.

You are receiving this letter because you are either currently enrolled in a plan through MNSure or you applied for health insurance in 2015 and requested help to pay for it.

If you are interested in continuing your coverage with financial help through MNSure in 2016, we need your authorization to get income information, including information from tax returns, in order to determine if you qualify for financial help to pay for your health insurance.

There are two ways you can give your authorization to MNSure. This information will be obtained securely and will **only** be used to determine your eligibility for help paying for health coverage.

**If we do not receive your authorization, you will not be able to receive financial help from MNSure, even if you otherwise would qualify for this assistance.**

### ONLINE OPTION

To complete the online form, you will need to provide your last name and IC Number, listed at the top of this page.

### PAPER OPTION

If you do not have internet access, call the MNSure Contact Center at 1-651-539-2240 and leave us a message with your contact information.

Please tell us the first and last name of the adults in your household, their birth dates, your address and the phone number we can use to contact you with any questions. We will send you the proper form and return envelope. You will need to complete this form and mail it back to MNSure.

**Open enrollment starts November 1, but please submit this form today.**

In order to have the most up-to-date information, we request you complete this process before **September 5, 2015**. Delaying may impact MNSure's ability to properly determine your eligibility for financial help in 2016.

Look for more information from us in the coming weeks as we approach the start of open enrollment on November 1.
