Mr. Gustafson presented the information in the packet. Commissioner Colombo motioned to approve a., b. & c. Running Aces 2024 Live Racing Requests: Second by Commissioner Dehn; Motion passed. Commissioner Goodman asked to amend c. to remove approval of the Paddock Judge Ms. Hinz until an updated resume could be provided. Commissioner Dehn motioned to approve the amendment; Second by Commissioner Koob; Motion passed.

#### d. Approval of Split Sample Laboratories for the 2024 Live Racing Season

Mr. Newton presented the 2024 Split Sample Laboratories: Kenneth L. Maddy Equine Analytical Laboratory Davis, California, Pennsylvania Equine Toxicology Research Laboratory Kennett Square, PA, and Analytical Forensic Testing Laboratory Chicago, IL. All of which are highly recommended by Dr. Hovda and have been approved Laboratories in past years by the MRC. Commissioner Goodman motioned to approve the Split Sample Laboratories for the 2024 Live Racing Season: Second by Commissioner Koob; Motion passed.

#### Agenda Item 6 - Status Reports

#### A. Canterbury Park Entertainment Running Aces Casino, Hotel and Racetrack

Mr. Sampson- Both simulcasting and cardroom had a good February, good weather and an extra day. The sports betting bill at the legislature, had disappointing amendments added for horse racing. There is a real concern on the impact to breeding, racing, revenues, and purse's if the horse racing industry is left out. 1 stall application has been received so far but indications are good, shipping incentive is having a good response. Congratulations to Andrew Offerman for being promoted to NYRA's Senior Vice President of Racing Operations. Commissioner Colombo asked Mr. Sampson to talk in a little greater detail about the impact that the bills would have on Canterbury. Mr. Sampson explained what they believe to be a very significant impact to racing. Gave the example of Prairie Meadows had a 10% decrease to table games and a significant decrease to their handle and ADW handle. Commissioner Dehn commented that the legislators do not understand what difference it makes if there is less money for purses, but still have horses racing. His question he would pose to the legislature is if they understand what's happening if you reduce the purses along with the reduction of betting at the track. Mr. Sampson replied yes, it is a complex question, and they are having difficulty educating. Chair McArdle commented that is not just potentially 10% decrease in revenues and purse money, this is also about people's livelihoods and their ability to remain in this industry. Jobs will go away and will have an economic impact on Minnesota. Commissioner Goodman commented that the Commission should let the legislators know we are concerned about the future of the horse racing industry. Commissioner Goodman made a motion to direct staff to prepare a letter of support for supporting the tracks at the capitol to be worked out with the chair and staff: Second by Commissioner Dehn; Motion passed. Commissioner Colombo asked about the economic study the MRC did and would like to see it attached to the letter.

#### A. Running Aces Casino, Hotel and Racetrack

Mr. Ito presented notes from Mr. Carpenito. Have 60 stall applications, 500+ horses. Applications deadline is April 9<sup>th</sup>. Personnel - happy to announce a new driver, Conrad Rapp. Have agreements with our association to race for \$6 million this year. Have also locked up all of their nonprofits that they work with every week whose proceeds go directly to them. Financially like Canterbury February was a positive month. Mr. Ito commented on the Sports Betting bill, and that another aspect in the bill that is significant is basically language that would freeze any new technology or any new forms of gaming, freeze it to what was written in 1984. This is very problematic; any industry has to have growth and has to have other forms of revenue.

#### Item 16 - MQHRA/MTA/MHRI/MNHBPA Reports

MTA – Kay King deferred to Mr. Bremer – In the past the MTA has had 4 sources of funding. 1. The SMSC marketing agreement that expired. 2. Stallion Auction sale, this year was a bust. 3. Yearling Sale in August, looking forward because of the dramatic drop in MN foals worried will not cover its cost. 4. Membership Dues, that is helpful but again with the drop in MN breeders cannot maintain and don't feel can dramatically increase the amount of the dues and retain people. The Executive board of the MTA had a meeting to discuss the financial crisis. Concluded that cannot afford a full time Executive Director. Not made the official decision yet but will soon at least go to part time Executive Director. Kay King has been an outstanding employee; we could not have run the organization as we have without her. This all goes back to lack of MN foals, 2014 had 275 registered foals, 2023 there was only 78. 2023 registered Mares were 115, this year 93. These are not sustainable numbers. eventually the whole Minnesota breeding program might fail. Long term, there is an impact on Canterbury Park, as MN Breds fill approximately 20% of races. This will be a significant hit to the field size which impacts handle and horses. MN Breeders need financial incentive to breed horses in MN. The economic impact on MN, the breeder is the start not the horse.

MHRI – Cathy Dessert –Introduced AJ Fetterly, the new Administrative Director for the MHRI. Her number is 651-829-7081 and email is <a href="MHRI@mnharness.com">MHRI@mnharness.com</a>. The American Horse Council recently published an economic impact study for all horse breeds, there is a breakout that was funded by the USTA for Harness Racing, helpful to the letter being written. Ms. Desert is the new USTA Director for this area and recently attended the meetings where there were 32 rule changes proposed, 16 were accepted. Message to legislature she tries to send is it is the horses; and the people, so please don't pass aside for politics. Hard message to deliver and most often not really understood.

**MNHBPA** – Mike Cronin – testified at the capitol, forwarded script to the commissioners. Many know about the educational programs, mental health counseling, and aftercare. Also have handed out various cards with bullet points about the economic impact. After testifying no one asked any questions from either side of the aisle. Chair McArdle asked if any plans for the summer? Mr. Cronin replied yes, a whole bunch, breakfast's, mariachi band festivals, movie nights. Also have Furlong Learning coming back.

Chair McArdle called the meeting to order at 4:00 p.m.

#### Roll Call:

#### Adoption of Agenda:

#### Agenda Item 3 – Approval of Agenda

Commissioner Dehn motioned to approve the agenda; Second by Commissioner Gingold; Motion passed.

#### Discussion Item:

Agenda Item 4 – Racetracks' Request for On-Track Advanced Deposit Wagering on Historical Horse Racing. Mr. Montross, Mr. Nelson and Ms. Wilson presented the Racetracks' request. Additional information was provided by Mr. True. Commissioners asked questions of Mr. True, Mr. Montross Mr. Nelson and Ms. Wilson. Chair McArdle then asked Mr. May to briefly explain Gaming Laboratories International and answer questions any of the Commissioners may have. Chair McArdle opened the floor to the individuals that signed up for public comment. Mike Cronin, HBPA President. Claudia Goebel, HBPA Vice-President. Dan Roland (Cathy Dessert read a statement from Mr. Roland). Cameron Mahlum, MTA President. Richard Bremer, MTA Vice-President. Greg Paulson, Brodeen & Paulson PLLP. Andy Platto, MN Indian Gaming Association. Jake Grassel, Citizens Against Gambling Expansion. Robert Molzon, SMSC. Josh Peterson, SMSC. AJ Fetterly, MNRI (read a statement for Cathy Dessert from the MHRI). Chair McArdle then read the names of additional people who had sent in letters in the past week. She then asked if any commissioners had comments or questions. Commissioner Dehn commented that as a commissioner he has a responsibility to look out for horse racing and the whole industry. Commissioner Gingold agreed with Commissioner Dehn.

Commissioner Gingold motioned the approval of Running Aces and Canterbury Parks January 4<sup>th</sup>, 2024, application for up to 500 terminals at each location for On-Track Advanced Deposit Wagering on Historical Horse Racing; Second by Commissioner Koob.

Commissioner Dehn motioned to add an amendment that this would be enforced or enacted on May 21, 2024, which is the date by statute the legislature is required to end session, so that parties can continue to discuss sports betting and to work until that time for an equitable agreement for all parties. But if no agreement is made May 21, 2024, would be the date that this motion would become effective; Second by Commissioner Colombo. Roll Call Vote: Commissioners Colombo, Dehn, Gingold, Goodman and Koob – yes; Commissioner Idelkope – no; Motion Passed.

Mr. Gustafson reminded the Commission that it is subject to Minn. Stat. §10.65 and the requirement to engage in consultation with tribal governments prior to the commission taking action if there is a significant tribal impact. As the Chair is aware, he has been working to set up a consultation meeting as early as next week. Several commissioners expressed concern as to why this had not been brought up before as the track's request was presented in January and it is now April, and a consultation meeting should have been scheduled prior to this meeting and should not be used as an attempt to delay action. Chair McArdle responded that a request for assistance in setting up a consultation meeting had been made quite some time ago and the Commission is finally getting that request met. Commissioner Colombo commented that the commission had consulted this year. Mr. Gustafson replied that the prior consultation meeting was on a different issue and consultation is not limited to one time a year. Chair McArdle noted that the agenda does not have an action item listed. This agenda was mainly a fact-finding meeting where everybody would be given the opportunity to explain everything, and we would be able to hear from different sides. Then would take all this information to digest, including over 200 pages of information and several hours of testimony and then come to a conclusion. Commissioner Idelkope expressed disappointment that this was being called for a vote today and was concerned about the legislative implications this vote may entail.

Commissioner Colombo called the question on Commissioner Gingold's motion to approve the racetracks' request. Roll Call Vote: Commissioners Colombo, Dehn, Gingold, Goodman and Koob – yes; Commissioner Idelkope – no; Motion Passed.

After the vote, Greg Paulson asked if the Commission would consider voting to approve a stay of its decision, to allow time for judicial review of the Commission's action. Evan Nelson asserted that because Commission's motion was to have the decision take effect on May 21, 2024, the Commission's action was not final.

Chair McArdle adjourned the meeting on Monday, April 1, 2024, at 7:23 p.m.

# Item 7 – HISA Voluntary Implementation Agreement

### FIRST ADDENDUM TO VOLUNTARY IMPLEMENTATION AGREEMENT

THIS FIRST ADDENDUM TO THE VOLUNTARY IMPLEMENTATION AGREEMENT (the "Amendment") is made effective as of December 23, 2023 (the "Effective Date"), by and among the Horseracing Integrity and Safety Authority, Inc., a Delaware non-profit corporation, 401 West Main Street, Unit 222, Lexington, Kentucky 40507 (the "Authority"), the Horseracing Integrity & Welfare Unit, a division of Drug Free Sport, LLC ("Drug Free Sport"), a Delaware limited liability company, 4801 Main Street, Suite 350, Kansas City, Missouri 64112 (the "Agency"), and the Minnesota Racing Commission, an agency of the Minnesota state government whose mailing address is 1100 Canterbury Road, Suite 100, Shakopee, MN 33379 (the "Commission"). As used herein, the "Parties" shall mean the Authority, the Agency or the Commission, individually.

WHEREAS, the Parties entered into a Voluntary Implementation Agreement dated April 28, 2023;

WHEREAS, the Parties agree to extend the term of the Agreement from December 23, 2023 to December 31, 2024;

WHEREAS, the Parties agree to amend the Agreement to add to and/or modify certain terms and conditions contained therein;

WHEREAS, the Parties hereto desire that all other terms and conditions of the Agreement not specifically amended herein shall remain in full force and effect; and

WHEREAS, on September 21, 2023, the Authority submitted to the Federal Trade Commission a Proposed Rule Modification to the Rule 2000 Series under the Horseracing Integrity and Safety Act of 2020 (the "Proposed Rule Modification").

NOW THEREFORE, in consideration of the covenants herein contained and other good and valuable consideration, the sufficiency of which is acknowledged, the Parties agree as follows:

1. The Parties agree that the Agreement shall be extended for one (1) additional year beyond the original term and that the final sentence in Section III (A)(1) of the Agreement shall be amended and replaced as follows:

<u>Term and Termination</u>. The Agreement shall be effective on the Program Effective Date. This Agreement shall terminate on December 31, 2024, unless the Parties agree in writing to extend the term of the Agreement beyond that date.

- 2. Section I (A) of the Agreement shall be amended and replaced as follows:
- A. <u>Safety Director</u>. The Commission names and appoints Dr. Lynn Hovda, Minnesota Racing Commission Chief Veterinarian as Safety Director of the State (the "Safety Director"). The Commission agrees to provide written notice of the individual appointed as Safety Director to the individual appointed as Safety Director as well as a management official for each racetrack under the Commission's jurisdiction. The Authority and the Commission agree that the Safety Director

shall carry out the duties and responsibilities set forth in Rule 2131 of the Racetrack Safety Program. Any person named to replace the individual named as Safety Director herein shall possess the necessary qualifications to perform the duties and responsibilities set forth in Rule 2131 of the Racetrack Safety Program. Dr. Hovda will ensure there is a culture of safety for the horses. She will oversee all aspects of equine safety and safety of veterinarian personnel working with horses by ensuring that all activities and practices involving the training and racing of horses at the track meet required safety standards. Dr. Hovda will provide guidance to attending veterinarians on safety issues and will maintain and annually review standard operating procedures and protocols for racehorse and veterinarian safety. She will participate in overseeing emergency drills that include equine injury and starting gate malfunction. Dr. Hovda will report equine injuries and fatalities to the Authority within seventy-two hours of injury. If for any reason Dr. Hovda is unable to carry out these duties the Commission may designate another licensed veterinarian to carry out these duties. In the event of a replacement, the Commission shall provide written notice to the Authority and a management official for each racetrack under the Commission's jurisdiction.

- 3. Section I (C) of the Agreement shall be amended and replaced as follows:
- C. <u>Regulatory Veterinarian</u>. The Commission names and appoints Dr. Lynn Hovda as Regulatory Veterinarian of the State (the "Regulatory Veterinarian"). The Authority and the Commission agree that the Regulatory Veterinarian shall carry out the duties and responsibilities of the Regulatory Veterinarian set forth in the Racetrack Safety Program, including but not limited to, the duties and responsibilities set forth in Rule 2135 of the Racetrack Safety Program. Any person named to replace the individual named as Regulatory Veterinarian herein shall possess the qualifications set forth in Rule 2134 of the Racetrack Safety Program. In the event of a replacement, the Commission shall provide written notice to the Authority and a management official for each racetrack under the Commission's jurisdiction.
  - 4. Section I(E) of the Agreement shall be amended and replaced as follows:
- E. <u>Trainers Test</u>. The Commission agrees to continue to require the use of its Minnesota state trainers test, which meets or exceeds the requirements set forth in Rule 2181 of the Racetrack Safety Program until such time as the Authority provides the Commission with a national trainer's test that the Commission shall be required to use; provided, however, that the Commission may supplement that national trainer's test with relevant sections of the Minnesota trainer's test unique to Minnesota state law and regulation, so long as such supplemental material does not contradict anything in the national trainer's test. Upon request by the Authority, the Commission shall provide documentation of satisfactory completion of the test for individual licensees. Upon the Authority's request, the Commission shall make its Minnesota state trainer's test available for review by the Authority.
  - 5. Section I (G) of the Agreement shall be amended and replaced as follows:
- G. <u>Concussion Management</u>. The Commission agrees to ensure the racetrack implements the Authority's Concussion Management Protocol for Jockeys.

- 6. <u>Coordination with Diagnostic Laboratory</u>. The Parties acknowledge that, as part of the Proposed Rule Modification, the Authority submitted to the Federal Trade Commission a proposed modification to Rule 2170 of the Racetrack Safety Program which states in pertinent part: "Racetracks or State Racing Commissions where the applicable State Racing Commission elects to enter into an agreement with the Authority shall coordinate with a diagnostic laboratory equipped with the facilities and trained personnel necessary to perform equine necropsies." If and when the Proposed Rule Modification is approved by the Federal Trade Commission, the Commission agrees to coordinate with a diagnostic laboratory equipped with the facilities and trained personnel necessary to perform equine necropsies as contemplated in Rule 2170. If requested by the Commission, the Authority agrees to utilize best efforts to assist the Commission in coordinating with a diagnostic laboratory.
  - 7. Section II (G)(1) and (2) shall be amended and replaced as follows:
  - (1) The Commission will receive, for the 2024 calendar year, the credit established by the Authority in its 2024 assessment to the commission, dated October 31, 2023, which will be applied to the amount paid to the Authority for that calendar year in connection with the funding required to be paid by the State to the Authority under the Act (the "State Testing Credit"). The State Testing Credit is an estimated amount for costs, including the costs of Agency-Authorized Collection Personnel required for the guaranteed minimum of Race Day testing, including Post-Race and TC02 testing, as well as the additional Post-Work, Vet's List, and/or out-of-competition testing all conducted on Race Days. These costs include travel, per diem, and other direct and actual costs associated with the collections conducted by Agency-Authorized Collection Personnel. The parties agree that, for the 2024 calendar year, the Commission's total State Testing Credit will be \$229,000.
  - (2) The Commission shall receive an additional credit reflecting the costs for any Agency-Authorized Collection Personnel who conduct additional out-of-competition testing outside of Race Day for the Agency during the term of this Agreement. The Parties agree that for the 2024 calendar year, the amount of the total out-of-competition testing credit (a) will not exceed \$57,000, and (b) will be calculated using the Commission's actual contract costs for the veterinarians conducting the work at an hourly rate of \$100/hour.
  - 8. Section II (K)(3) shall be amended and replaced as follows:
  - (3) The Commission agrees to provide the Agency with (a) a certification that all Agency-Authorized Collection Personnel (i) have satisfactorily completed a background check in accordance with state law with a completion date no earlier than 1 year prior to the individual's certification date and (ii) are in good standing with the track(s) at which they will collect samples for the Agency; and (b) completed conflict of interest statements (in a form specified by the Agency) from all Agency-Authorized Collection

Personnel. The Commission understands that the requirements of subparagraphs (a) and (b) are a condition of certification of Agency-Authorized Collection Personnel by the Agency. Additionally, the Commission agrees to notify the Agency immediately upon any termination or contract of any Agency-Authorized Collection Personnel.

9. Except as otherwise provided in this Addendum, all terms and conditions of the Agreement shall remain in full force and effect.

### **VOLUNTARY IMPLEMENTATION AGREEMENT**

THIS VOLUNTARY IMPLEMENTATION AGREEMENT (this "Agreement") is entered into as of 28<sup>th</sup> day of April 2023, by and among the Horseracing Integrity and Safety Authority, Inc., a Delaware non-profit corporation whose mailing address is 401 West Main Street, Unit 222, Lexington, Kentucky 40507 (the "Authority"), the Horseracing Integrity & Welfare Unit, a division of Drug Free Sport, LLC ("Drug Free Sport"), a Delaware limited liability company whose mailing address is 4801 Main Street, Suite 350, Kansas City, Missouri 64112 (the "Agency"), and the Minnesota Racing Commission, an agency of the Minnesota state government whose mailing address is 1100 Canterbury Road, Suite 100, Shakopee, MN 33379 (the "Commission"). As used herein, the "Parties" shall mean the Authority, the Agency and the Commission, collectively; and a "Party" shall mean the Authority, the Agency or the Commission individually.

WHEREAS the Authority is a private, independent, self-regulatory, nonprofit corporation that was recognized for the purpose of developing and implementing a horseracing anti-doping and medication control program and a racetrack safety program for covered horses, covered persons, and covered horseraces by the Horseracing Integrity and Safety Act of 2020, as amended (the "Act");

WHEREAS Drug Free Sport, a sport drug testing industry who administers comprehensive drug testing programs, manages national and international collections, and develops drug testing policies for a wide range of organizations around the world, created an entity to act as the anti-doping and medication control enforcement agency under the Act and to develop and enforce an independent and uniform thoroughbred anti-doping and medication control program ("ADMC Program");

**WHEREAS** the Agency was created to act as the anti-doping and medication control enforcement agency under the Act and to develop and enforce the ADMC Program;

**WHEREAS** the Commission is the independent agency of state government vested with jurisdiction to regulate the conduct of horse racing and pari-mutuel wagering on horse racing and related activities within the state of Minnesota (the "State");

WHEREAS 15 USC § 3054(e)(2) of the Act permits the Authority to enter into agreements with state racing commissions for services consistent with the enforcement of the racetrack safety program (the "Racetrack Safety Program"), and 15 USC § 3060 permits the Authority to enter into agreements with state racing commissions for services consistent with the enforcement of the ADMC Program;

WHEREAS 15 USC § 3054(e)(2)(A) of the Act permits the Agency to enter into agreements with state racing commissions for services consistent with the enforcement of the ADMC Program; and

**WHEREAS** the Authority has determined that the Commission has the ability to implement certain areas of the Racetrack Safety Program in accordance with the rules, standards, and requirements established by the Act and the Authority; and

**WHEREAS** the Authority and the Agency have determined that the Commission has the ability to implement certain areas of the ADMC Program in accordance with the rules, standards, and requirements established by the Act, the Authority, and the Agency.

**NOW THEREFORE**, in consideration of the covenants herein contained and other good and valuable consideration, the sufficiency of which is acknowledged, the Parties agree as follows:

### I. Racetrack Safety Program

- Safety Director. The Commission names and appoints Dr. Lynn Hovda, Α. Minnesota Racing Commission Chief Veterinarian as Safety Director of the State (the "Safety Director"). The Authority and the State agree that the Safety Director shall carry out the duties and responsibilities of the Safety Director set forth in the Racetrack Safety Program, including, but not limited to, the duties and responsibilities set forth in Rule 2131 of the Racetrack Safety Program. Any person named to replace the individual named as Safety Director herein shall possess the necessary qualifications to perform the duties and responsibilities set forth in Rule 2131 of the Racetrack Safety Program. Dr. Hovda will ensure there is a culture of safety for the horses. She will oversee all aspects of equine safety and safety of veterinarian personnel working with horses by ensuring that all activities and practices involving the training and racing of horses at the track meet required safety standards. Dr. Hovda will provide guidance to attending veterinarians on safety issues and will maintain and annually review standard operating procedures and protocols for racehorse and veterinarian safety. She will participate in overseeing emergency drills that include equine injury and starting gate malfunction. Dr. Hovda will report equine injuries and fatalities to the Authority within seventy-two hours of injury. If for any reason Dr. Hovda is unable to carry out these duties, the Commission may designate another licensed veterinarian to carry out these duties.
- B. <u>Stewards</u>. The Commission agrees that the stewards shall enforce the safety regulations set forth in the Rule 2200 Series of the Racetrack Safety Program. The Commission further agrees that the stewards shall also serve in the adjudicatory capacities set forth in the Rule Series 8000, "Enforcement Rules."
- C. <u>Regulatory Veterinarian</u>. The Commission names and appoints Dr. Lynn Hovda as Regulatory Veterinarian of the State (the "Regulatory Veterinarian"). The Authority and the State agree that the Regulatory Veterinarian shall carry out the duties and responsibilities of the Regulatory Veterinarian set forth in the Racetrack Safety Program, including, but not limited to, the duties and responsibilities set forth in Rule 2135 of the Racetrack Safety Program.

Any person named to replace the individual named as Regulatory Veterinarian herein shall possess the qualifications set forth in Rule 2134(a) Racetrack Safety Program.

- D. <u>Emergency Warning Systems</u>. The Commission agrees to approve the racetrack emergency warning systems in use on all racing and training tracks at each racetrack under the jurisdiction of the Commission, as set forth in Rule 2153 of the Racetrack Safety Program.
- E. <u>Trainers Test.</u> The Commission agrees to require the use of the Authority's uniform National Trainers Test, as set forth in Rule 2181.
- F. <u>Testing Program</u>. The Commission agrees to conduct testing in cooperation with the racetrack regarding alcohol and drugs for Jockeys, as set forth in Rule 2191 of the Racetrack Safety Program. The Commission further agrees to submit the protocol for the testing program to the Authority. Upon request by the Authority, and in compliance with state and federal laws, the Commission shall share with the Authority information pertaining to positive tests of individual Jockeys and shall make periodic reports concerning the testing program as directed by and on forms prescribed by the Authority.
- G. <u>Concussion Management</u>. The Commission agrees to ensure the racetrack implements a concussion management program for Jockeys, as set forth in Rule 2192 of the Racetrack Safety Program. The Commission further agrees to submit the protocol for the concussion management program to the Authority.
- H. Racetrack Safety Program Scope of Work. The scope of work and reporting obligations for the Racetrack Safety Program under this Agreement are those set forth in the Rule 2000 Series, "Racetrack Safety and Accreditation," and any additional policies and procedures implemented by the Authority which are consistent with the Act and any regulations approved by the Federal Trade Commission pursuant to the Act ("HISA Policies"). Copies of HISA Policies will be communicated to the Commission. The Commission agrees to provide performance metrics in reasonable detail and at reasonable intervals on forms to be prescribed by the Authority.
- I. Indemnification. The Authority expressly agrees to indemnify and hold harmless the Commission and its agents, contractors or employees from and against any and all claims, loss, damages, injury, liability and costs, including but not limited to reasonable attorneys' fees and court costs, resulting from, or arising out of, the Racetrack Safety Program Scope of Work as defined in this Agreement, except to the extent that such liability, loss, expense, attorneys' fees, or claims for injury or damages are caused by, or result from, the breach of this Agreement by, or the negligence, willful misconduct, or intentional acts or omissions of, the Commission or its employees, contractors or agents. Any enforcement actions related to the Racetrack Safety Program Scope of Work will be the responsibility of and will be defended by the Authority. Any appeals or challenges to actions taken by Commission agents, contractors or employees when enforcing the Act or federal rules or regulations promulgated pursuant to the Act will proceed

pursuant to the enforcement rules of the Act and will be defended by the Authority. Notwithstanding anything set forth in this Agreement to the contrary, this Agreement shall not be construed to waive any immunity under applicable state law, including, but not limited to, sovereign immunity, possessed by the Commission and its agents, contractors, or employees.

### II. ADMC Program

### A. ADMC Program Testing.

- (1) The Commission agrees that the personnel used to conduct collections for thoroughbred race horses in the State (including, but not limited to, its employees and/or contractors) will conduct Sample collections in the State for, and under the authority of, the Agency pursuant to Rule Series 3000, "Equine Anti-Doping and Controlled Medication Protocol," including, but not limited to, the regulations under Rule 3130 (Testing & Investigations), and Rule Series 5000, "Equine Testing and Investigation Standards," of the ADMC Program, including, but not limited to, Post-Race Samples, Post-Work Samples, TCO2 testing, testing of Claimed Horses and Out-of-Competition Samples (the "Agency Samples"). Pursuant to Rule 5450, the Agency will authorize these personnel (the "Agency-Authorized Collection Personnel") to conduct sample collections for the ADMC Program. The Commission agrees to conduct testing at the racetrack and only immediately prior to, during or after the race meet. Any other times or locations must be specifically agreed to by the Commission and the Agency in writing (including by email).
- (2) <u>Testing Liaison</u>. The Commission names and appoints Dr. Lynn Hovda or veterinarians licensed by the Commission as HIWU Testing Liaison of the State (the "HIWU Testing Liaison"). The Agency and the State agree that the Testing Liaison shall be the point-of-contact with the Agency for (a) the scheduling of the collections of Agency Samples by Agency-Authorized Collection Personnel, (b) any problems or issues that arise during collections of Agency Samples by Agency-Authorized Collection Personnel, and (c) the delivery of any notice required under Rule Series 3000, "Equine Anti-Doping and Controlled Medication Protocol," to individuals present at racetracks or training facilities in the State. Any person named to replace the individual named as HIWU Testing Liaison shall be confirmed in written notice to the Agency.
- (3) The Commission agrees that Agency-Authorized Collection Personnel will comply with the policies, procedures and instructions of the Agency while conducting the Sample collections for Agency Samples. With the exception of scheduling for Agency-Authorized Collection Personnel and monitoring Agency-Authorized Collection Personnel when they are carrying out responsibilities in accordance with the ADMC Program, the Commission agrees that it will not, in any way, be involved in the collection of Agency Samples, including, but not limited to, instructing or directing such State Sample Collection Personnel on which horses should be selected for testing at a given race or event, unless authorized by the Agency to

do so. The Commission agrees that only Agency-Authorized Collection Personnel will be involved in the collection of Agency Samples, including giving directions and instructions to other Agency-Authorized Collection Personnel with respect to how to conduct any portion of a Sample collection.

(4) The Commission understands that, under the Act, no ADMC Program testing of Covered Horses will occur in the State unless it is at the direction of the Agency or has been authorized in advance and in writing by the Agency. No ADMC Program testing will occur under the ADMC Program prior to the effective date of the ADMC Program (the "Program Effective Date"). The Program Effective Date will not occur if the Authority does not have jurisdiction under the Act.

### B. <u>ADMC Program Investigations.</u>

- (1) The Commission agrees that Commission personnel currently used to conduct investigations in the State (including, but not limited to, its employees and/or contractors) will conduct investigations in the State (the "State Investigative Personnel") for, and at the direction of, the Agency pursuant to Rule Series 3000, "Equine Anti-Doping and Controlled Medication Protocol," including, but not limited to, the regulations under Rule 3130 (Testing & Investigations), and Rule Series 5000, "Equine Testing and Investigation Standards," including the regulations under Rule 5700 (Standards for Investigations) of the ADMC Program (the "Agency Investigations").
- (2) <u>Investigations Liaison</u>. The Commission names and appoints Commission Stewards, Randy Blaseg, Reuben Rivera, and Gregory Hosch, as Investigations Liaisons of the State (the "Investigations Liaisons"). The Agency and the State agree that the Investigations Liaisons shall be the point-of-contact with the Agency for the scheduling of any investigatory work requested by the Agency pursuant to subparagraph (1) above. Any person named to replace the individual(s) named as Investigations Liaison shall be confirmed in written notice to the Agency. In connection with Agency Investigations, the Investigations Liaison and State Investigative Personnel shall be deemed designees of the Authority pursuant to Rule 8400 (Investigatory Powers).
- (3) The Commission agrees that State Investigative Personnel will comply with the policies, procedures and instructions of the Agency while conducting these Agency Investigations, and the Commission will not, in any way, be involved in decision-making in connection with these Agency Investigations, including, but not limited to, instructing or directing such State Investigative Personnel on which individuals or horses should be investigated, or when or where to conduct an Agency Investigation.
- (4) The Commission understands that, under the Act, the Commission shall not conduct any investigation pertaining to the ADMC Program, including, but not limited to, any interviews or searches of any kind, relating to any Covered Horse unless it is at the direction of

the Agency. No Agency Investigations will occur pursuant to this Agreement prior to the Program Effective Date.

- C. <u>Access to Racetracks</u>. The Commission agrees that any individual who presents a credential or letter of authorization issued by the Agency will be permitted access to any racetrack in the State at which Covered Horses compete, and such access will include all areas of the racetracks, including, but not limited to, the back stretch.
- D. Regulatory Veterinarian. As set forth in Paragraph I.D above, the Commission names and appoints Dr. Lynn Hovda as the Regulatory Veterinarian. The Parties agree that the Regulatory Veterinarian shall carry out the duties and responsibilities of the Regulatory Veterinarian set forth in the ADMC Program, including, but not limited to, the duties and responsibilities set forth in Rule Series 3000, "Equine Anti-Doping and Controlled Medication Protocol," and Rule Series 5000, "Equine Testing and Investigation Standards." Any person named to replace the individual named as Regulatory Veterinarian herein shall possess the qualifications set forth in Rule 2134(a) of the Racetrack Safety Program under the Act, and such replacement requires the prior written approval of the Agency.

### E. <u>Additional Testing</u>.

- (1) In addition to any Agency Samples collected at the direction of the Agency, the Commission may, under Rule 3132 (Authority to Test), request additional samples be collected from thoroughbred horses present in the State. Any such request must be made in writing to the Agency (attention: Kate Mittelstadt, Chief of Operations at HIWU@hiwu.org) and must include all the specific details of the requested testing (e.g., sample types, dates, location, rationale).
- (2) The Agency may, in its absolute discretion, approve or reject the request. If the request is rejected, the Commission agrees that the requested testing will not be conducted by any person, organization, or entity within its authority or control. If the request is granted, (i) the Agency will determine which sample collection personnel will conduct the testing (i.e., Agency-Authorized Collection Personnel or personnel retained by the Agency), (ii) the collections will comply with Rule Series 3000, "Equine Anti-Doping and Controlled Medication Protocol," and Rule Series 5000, "Equine Testing and Investigation Standards," and (iii) all of the results of such testing will be sent to, and processed by, the Agency pursuant to Rule Series 3000, "Equine Anti-Doping and Controlled Medication Protocol," including all of the regulations in Rules 3240 and 3340 (Results Management)
- (3) For each calendar year in which additional testing in the State is approved and conducted pursuant to this Paragraph II.E, the Commission agrees to cover the following expenses for such additional testing: the actual cost for collection personnel, equipment, shipping, and laboratory expenses.

### F. <u>Testing Laboratories</u>.

- (1) For the 2023 calendar year, the Commission agrees that Agency Samples will be sent to, and the Agency Samples which are "A" samples will be analyzed by, Industrial Laboratories (the "State-Appointed Testing Laboratory"). For each subsequent year of this Agreement, the Commission will appoint the State-Appointed Testing Laboratory by the September 30 of the prior year (e.g., September 30, 2023 for 2024) by providing written notice of the appointment to the Agency. The State-Appointed Testing Laboratory must be a laboratory accredited by the Agency.
- (2) The Commission understands that, under the Act, any analysis performed on Agency Samples which are "B" Samples will be sent to, and analyzed by, a laboratory selected by the Agency that is different from the State-Appointed Testing Laboratory.
- (3) Notwithstanding any laboratory selection made by the Commission pursuant to subparagraph (1) above, if the laboratory selected by the Commission cannot adequately analyze any Agency Sample for any specific substance or method requested by the Agency, the Commission understands that, under the Act, the Agency may have the Samples (both "A" and "B") sent to a different laboratory of the Agency's choosing. The Commission also understands that the Agency has the authority to direct further analysis on all Agency Samples at its discretion.

### G. <u>Credits for Testing</u>.

- (1) The Commission will receive, for the 2023 calendar year, the credit established by the Authority in its 2023 assessment to the Commission, dated December 28, 2022, which will be applied to the amount paid to the Authority for that calendar year in connection with the funding required to be paid by the State to the Authority under the Act (the "State Testing Credit"). The State Testing Credit is an estimated amount for costs, including the costs of Agency-Authorized Collection Personnel required for the guaranteed minimum of Race Day testing, including Post-Race and TCO2 testing, as well as additional Post-Work, Vet's List and/or out-of-competition testing all conducted on Race Days, and testing of all Claimed Horses. These costs include travel, per diem, labor and other direct and actual costs associated with the collections conducted by Agency-Authorized Personnel. The parties agree that, for the 2023 calendar year, the Commission's total State Testing Credit will be \$280,000.
- (2) The Commission shall receive an additional credit reflecting the costs for any Agency-Authorized Collection Personnel who conduct additional out-of-competition testing outside of Race Day for the Agency during the term of this Agreement. The Parties agree that for the 2023 calendar year, the amount of the total out-of-competition testing credit (a) will not exceed \$60,000, and (b) will be calculated using the Commission's actual contract costs for the veterinarians conducting the work at an hourly rate of \$90.00.

- (3) In each subsequent year of this Agreement, the Agency will provide the State with the annual State Testing Credit by the November 1 of the previous year (e.g., November 1, 2023 for 2024).
- (4) The Commission agrees that it will provide the Agency with a list of the thoroughbred racing days to be held in its State in the subsequent calendar year, including dates, locations, and number of races each day upon Commission approval of Race Days requests. The Commission also agrees to provide the Agency with prompt notice of any changes to this list within two weeks of any such change.
- H. <u>Reimbursement for Investigations</u>. The Agency agrees to reimburse the Commission for any actual costs or expenses incurred in connection with any Agency Investigation in the State conducted pursuant to Paragraph II.B above. The Commission agrees to invoice the Agency quarterly for such costs and expenses at a rate of \$80 per hour.
- I. <u>Training Opportunities</u>. The Commission agrees to identify existing, or provide locally, training opportunities for all Agency-Authorized Collection Personnel and State Investigations Personnel to be organized in conjunction with the Agency. Any Commission sponsored training shall be reimbursed at a rate commensurate with the Commission's contract with the provider of the training. The Commission further agrees that the Agency may request and review information pertaining to the training opportunities available to Agency-Authorized Collection Personnel and State Investigations Personnel.
- J. Arbitration Procedures. The Commission understands that, under the Act, any anti-doping rule or controlled medication rule violations alleged to have occurred in the State will be processed pursuant to Rule Series 7000, "Arbitration Procedures," and that, under these regulations, alleged anti-doping rule violations will be heard by the Arbitral Body and alleged controlled medication rule violations will be heard by the Internal Adjudication Panel. The Commission agrees that its employees, consultants and other agents (including, but not limited to, Agency-Authorized Collection Personnel and State Investigative Personnel) will cooperate with any process or proceeding conducted pursuant to the Arbitration Procedures, including, but not limited to, providing documents and testimony in connection with the case or matter and will be compensated for this activity pursuant to Paragraph H. above. The Agency understands that any costs associated with the preparation, testimony or any other expenses incurred by Agency-Authorized Collection Personnel or State Investigative Personnel shall be the sole responsibility of the Agency.

### K. <u>ADMC Program Scope of Work.</u>

(1) The scope of work and reporting obligations for the ADMC Program ("State Requirements") under this Agreement are those set forth in the Rule Series 3000, "Equine Anti-Doping and Controlled Medication Protocol," Rule Series 5000, "Equine Testing and Investigation Standards," and any additional policies and procedures implemented by the Agency

which are consistent with the Act and any regulations approved by the Federal Trade Commission pursuant to the Act ("HIWU Policies"). Copies of HIWU Policies will be communicated to the Commission. General State Requirements are set forth on Exhibit A to this Agreement.

- (2) The Commission understands that Agency-Authorized Collection Personnel must acquire and maintain certification from the Agency in order to be permitted to conduct collections of Agency Samples. The Authority shall reimburse the costs of such training. The Commission agrees to provide information relating to the compliance of its Agency-Authorized Collection Personnel with the Rule Series 3000, "Equine Anti-Doping and Controlled Medication Protocol," Rule Series 5000, "Equine Testing and Investigation Standards," and HIWU Polices at reasonable intervals and on forms to be specified by the Agency.
- (3) The Commission agrees to provide the Agency with (a) a certification that all Agency-Authorized Collection Personnel have satisfactorily completed a background check within a completion date no earlier than the Program Effective Date, and (b) completed conflict of interest statements (in a form specified by the Agency) from all Agency-Authorized Collection Personnel. The Commission understands that the requirements of subparagraphs (a) and (b) are a condition of certification of Agency-Authorized Collection Personnel by the Agency.
- (4) If at any time during the term of this Agreement, the Agency, with good cause, believes that any individual Agency-Authorized Collection Personnel or State Investigative Personnel is not satisfying the requirements set forth in this Agreement, it shall notify the Commission of the reasons for its good faith basis in writing. The Commission agrees to take any necessary action to promptly correct the non-compliant conduct or prevent any future non-compliance to the satisfaction of the Agency. If the individual at issue continues to be non-compliant, or if the initial conduct was so egregious as to warrant removal (as determined by the Agency in its sole discretion), then the Agency may revoke the individual's certification and require the Commission to cease assigning said individual to perform further services under this Agreement. The Commission shall promptly comply with such request. Any action by the Agency under this Paragraph shall in no way affect the employment status of any individual and shall in no way impair the Commission's right to continue to employ such individual. The Agency acknowledges that Agency-Authorized Collection Personnel and State Investigative Personnel are not employees of the Agency.

### L. Information Sharing.

(1) The Commission agrees that it will provide the Agency, on a timely basis, with any information, documentation, or evidence that it receives or discovers relating to possible violations of the ADMC Program.

- (2) The Agency agrees that it will provide the Commission, on a timely basis, with any information, documentation, or evidence that it receives or discovers relating to possible violations of the State's laws, regulations, or rules applicable to racing horses other than Covered Horses.
- (3) In addition to any notifications required by the Act to be made by the Agency to the Commission, the Agency will make its best efforts to notify the Commission of negative tests from the Agency Samples that are "A" Samples for a specific Race Day within three (3) business days of the Agency's receipt of those results from the State-Appointed Testing Laboratory. This notification will be made by email to Dr. Lynn Hovda at lynn.hovda@state.mn.us and Kyle Gustafson at kyle.gustafson@state.mn.us once all of the results for that day have been received by the Agency. The Commission agrees that all purses will be held until notification of results is received by the Commission from the Agency.

### M. Confidentiality.

- (1) The Commission agrees that the content of any notices, including EAD Notices under Rule 3245 and ECM Notices under Rule 3345, received by it from the Agency pursuant to the Rule Series 3000, "Equine Anti-Doping and Controlled Medication Protocol," (the "Confidential Information") will not be publicly disclosed by the Commission or its officers, directors, employees, or agents unless and until (a) that information has been publicly disclosed by the Agency pursuant to the requirements of the Act, or (b) the Agency has given written consent for the information to be disclosed. In addition, the Commission agrees not to disclose the Confidential Information to any person other than to such of its officers, directors, employees, contractors or agents who have a need to know and who agree to be bound by the confidentiality provisions hereof. The Commission agrees that it will be responsible for any breach of this Agreement by its officers, directors, employees, contractors or agents.
- (2) Upon receipt of any request for the disclosure of documents relating to the ADMC Program, the Commission agrees to provide the Authority and/or the Agency with appropriate notification and opportunity to challenge the disclosure of such records in accordance with applicable state and/or federal law.
- N. <u>Indemnification</u>. The Authority expressly agrees to indemnify and hold harmless the Commission and its employees, contractors or agents from and against any and all claims, loss, damages, injury, liability and costs, including, but not limited to, reasonable attorneys' fees and court costs, resulting from, or arising out of, the ADMC Program Scope of Work as defined in Paragraph II.K above, except to the extent that such liability, loss, expense, attorneys' fees, or claims for injury or damages are caused by, or result from, the breach of this Agreement by, or the negligence, willful misconduct, or intentional acts or omissions of, the Commission or its employees or agents. Commission veterinarians shall conform to all state statutes, rules, and professional standards regarding equine health and safety, notwithstanding any Agency investigations. The Authority will hold the Commission, its employees, and its contractors

harmless when a Commission veterinarian acts in compliance with state law and professional standards regarding equine health and safety. Any enforcement actions related to the ADMC Program Scope of Work will be the responsibility of, and will be defended by, the Authority and the Agency. Any appeals or challenges to actions taken by Commission employees, contractors or agents when enforcing the Act or federal rules or regulations promulgated pursuant to the Act will proceed pursuant to the enforcement rules of the Act and will be defended by the Authority and the Agency. Notwithstanding anything set forth in this Agreement to the contrary, this Agreement shall not be construed to waive any immunity under applicable state law, including, but not limited to, sovereign immunity, possessed by the Commission and its agents, contractors, or employees.

### **III.** General Provisions

### A. Term and Termination.

- (1) This Agreement shall be effective on the Program Effective Date. If the Agreement requires further approvals of any other state agency, commission, board or authority under applicable state law, if such approval does not occur on or before the Program Effective Date, this Agreement shall terminate and be of no force or effect. This Agreement shall terminate on December 23, 2023, unless the Parties agree in writing to extend the term on the Agreement beyond that date.
- (2) This Agreement may be terminated by any Party upon one hundred twenty (120) days written notice. This Agreement may be terminated immediately by the Commission if either: (a) the Horseracing Integrity and Safety Act of 2020 (as amended) is found unconstitutional by a court of competent jurisdiction, with all appeals being exhausted; or (b) the Authority or the Agency is enjoined or restrained from operation by a court of competent jurisdiction.
- (3) This Agreement may be terminated by the Agency upon sixty (60) days written notice if the Agency has determined, in good faith, that the Commission, Agency-Authorized Collection Personnel, or State Investigative Personnel have failed to substantially comply with the requirements of Rule Series 3000, "Equine Anti-Doping and Controlled Medication Protocol," Rule Series 5000, "Equine Testing and Investigation Standards," or any HIWU Policy. Any written notice provided pursuant to this subparagraph shall include the basis for the Agency's determination.
- (4) If any Party defaults in a material obligation under this Agreement and continues in default for a period of thirty (30) days after written notice of default is given to it by another Party, the other Party may terminate and cancel this Agreement, immediately upon written notice of termination given to the defaulting Party.
- (5) If this Agreement is terminated pursuant to this Paragraph III.A, (a) any State Testing Credit provided to the Commission pursuant to Paragraph II.G above will be reduced on

a pro-rata basis, (b) the certification of all Agency-Authorized Collection Personnel will be revoked by the Agency, and (c) the Agency will, pursuant to the Act, take direct control of all anti-doping and controlled medication testing and investigative operations in the State with respect to Covered Horses.

- (6) In addition to any right of termination granted to the Agency pursuant to this Agreement, the Agency may request that the Authority reduce the Commission's Testing Credit, on a pro-rata basis, for any period of time that the Agency determines that the Commission has not complied with its material obligations under this Agreement. The Agency will provide the Authority and the Commission written notice of the request, which will include the basis for the Agency's determination and the time period covered by the request. The Authority will make a decision on the request within thirty (30) days of receiving the Agency's request.
- B. <u>Notices</u>. All notices required to be provided hereunder shall be in writing and shall be deemed delivered if (1) sent by facsimile, upon confirmation of faxing, (2) if sent by overnight courier, by the date after mailing, (3) if by hand delivery, upon actual receipt or (4) if by certified mail, return receipt requested and postage prepaid, on the third business day after deposit in the mails, to the addressee set forth below (with a copy emailed to the email addresses set forth below) or at such other location as such Party notifies the other pursuant to this provision.

- C. <u>Severability</u>. If any part of this Agreement is determined to be invalid or illegal by any court or agency of competent jurisdiction, then that part shall be limited or curtailed to the extent necessary to make such provision valid, and all other remaining terms of this Agreement shall remain in full force and effect.
- D. <u>Entire Agreement</u>. This Agreement constitutes the entire agreement among the Parties and supersedes all prior and contemporaneous agreements and understandings, whether written or oral, among the Parties with respect to the subject matter hereof.
- E. <u>Amendment and Waiver</u>. This Agreement may be modified or amended only in a writing signed by all Parties. A Party's failure to act hereunder shall not indicate a waiver of its rights hereto. No waiver of any provision of this Agreement shall be valid unless made in writing and signed by the waiving Party. The failure of any Party to require the performance of any term or obligation of this Agreement or the waiver by any Party of any breach of this Agreement shall not prevent any subsequent enforcement of such term and shall not be deemed a waiver of any subsequent breach.
- F. <u>Governing Law</u>. This Agreement shall be governed by, and construed and interpreted in accordance with, the laws of the state of Minnesota, without regard to its conflicts of laws principles.
- G. <u>Assignability</u>. The Agency may assign this Agreement to an affiliate, a successor in connection with a merger, acquisition, or consolidation, or to the purchaser in connection with the sale of all or substantially all of Service Provider's assets without notice to the Commission. This Agreement and all of the terms and provisions hereof will be binding upon, enforceable against, and will inure to the benefit of, the Parties hereto and their respective successors and assigns.
- H. <u>Counterparts</u>. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original and all of which together shall constitute one instrument. Any signature page delivered by facsimile, telecopy machine, portable document format (.pdf) or email shall be binding to the same extent as an original.

I. <u>Headings; Interpretation</u>. The headings in this Agreement have been included solely for ease of reference and shall not be considered in the interpretation or construction of this Agreement. All references herein to the masculine, neuter or singular shall be construed to include the masculine, feminine, neuter or plural, as appropriate.

- Coordination of Stewards to assist with directing the selection of horses to the Test Barn on Race Days pursuant to HIWU Policies
- Coordination of training and certification of Agency-Authorized Collection Personnel
- Coordination of training of State Investigations Personnel
- Minimum employment and workers' compensation insurance policies required by law for Agency-Authorized Collection Personnel and State Investigative Personnel.
- Required work permits/authorizations for collection and investigations personnel for Agency-Authorized Collection Personnel

Dear Kyle,

I have completed HISA's calculation of the 2023 True-Up. This calculation includes the following components:

- Actual Starts/Purses Paid The HISA Assessment Methodology approved by the FTC requires that we true-up the 2023 assessments using each track's actual starts and purses paid during the 2023 calendar year (the assessment was initially calculated using the starts and purses paid during the period Oct. 1, 2021 through Sep. 30, 2022 as a projection).
- Money being returned by HISA to the industry in 2023 HISA spent less than the amount of assessments collected, and therefore we are returning \$2,771,839 to the industry.
- Shortfall/Overage of 2023 Credits Earned 2023 assessments in many states included credits for the estimated costs incurred by states/tracks for the payment of sample collection personnel and related items like laboratory credits. HIWU has now calculated the actual credits earned, and the difference has been included in the 2023 True-Up. A substantial portion of the credit difference was due to the delayed start of the ADMC Rules.
- <u>Investigation Credits Earned</u> several states used their personnel to conduct investigations requested by HIWU. Those states that weren't reimbursed for the cost of these investigations received a credit in the 2023-True Up.

Attached is a document (Addendum 1) that, for your state and each of the tracks in it, summarizes the following:

- 2024 Gross Assessment
- 2024 Estimated Credits Offered
- 2023 True-Up (including the components outlined above) please note that in any state which still owes money to HISA for 2023 and which has a credit balance in the 2023 True-Up, this credit balance is netted against the 2023 amount owed before it is netted against the 2024 assessment.



Through March, monthly invoices issued by HISA have been based on the amount included in the correspondence you were sent on or around Oct. 31, 2023 (which included a preliminary estimate of 2024 HIWU credits and did not include the 2023 True-Up). Starting on April 1, monthly invoices will reflect current information and will be in the amount necessary to correctly assess each state/track during the 2024 calendar year.




