

Order of Removal of Stayed Suspension

This matter came before the Complaint Review Panel ("Panel") of the Minnesota Office of Emergency Medical Services, under delegated authority from the Director of the Office of Emergency Medical Services, in accordance with the terms of a July 22, 2024, Findings of Facts, Conclusions, and Final Order ("2024 Final Order"), which reinstated the paramedic certification of Brynne Margie Werner ("Respondent") under the terms of a March 21, 2024, Stipulation and Consent Order ("2024 Consent Order") agreed to and signed by Respondent.

Pursuant to the 2024 Final Order and 2024 Consent Order, the Minnesota Emergency Medical Services Regulatory Board¹ suspended Respondent's paramedic certification but stayed the suspension contingent upon Respondent's compliance with all terms and conditions in the 2024 Final Order and the 2024 Consent Order. In paragraph 11 of the 2024 Consent Order, Respondent expressly acknowledged and agreed that the Panel is authorized to issue an Order of Removal of Stay of Suspension ("Order of Removal") if it has probable cause to believe Respondent has failed to comply with or has violated any of the requirements for staying the suspension of Respondent's certification.

The Panel has probable cause to believe Respondent has failed to comply with or has violated one or more of the requirements for staying the suspension of Respondent's certification.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that the stay of suspension set forth in the 2024 Final Order and 2024 Consent Order is **REMOVED**, and Respondent's paramedic certification in the State of Minnesota is **SUSPENDED** immediately.

¹ Effective January 1, 2025, the responsibilities to regulate emergency medical services in Minnesota under Minnesota Statutes, chapter 144E, and Minnesota Rules, chapter 4690, were transferred from the Emergency Medical Services Regulatory Board to the Office of Emergency Medical Services and the Director of the Office of Emergency Medical Services. 2024 Minn. Laws ch. 127, art. 63, § 21; Minn. Stat. § 15.039.

IT IS FURTHER ORDERED that Respondent's paramedic certification in the State of Minnesota will remain suspended until the Director makes a final determination in this matter.

IT IS FURTHER ORDERED that Respondent's violation of this Order will provide grounds for further disciplinary action pursuant to Minnesota Statutes section 144E.28, subdivision 5(a)(1).

IT IS FURTHER ORDERED that the Director may, at any time following service of this Order of Removal and a Notice of Removal of Stay of Suspension, Imposition of Suspension, and Hearing upon Respondent in accordance with the requirements of the 2024 Final Order and 2024 Consent Order, take any of the following actions:

- 1. Dismiss the Panel's allegations and reinstate Respondent's paramedic certification under the terms of the 2024 Final Order and 2024 Consent Order.
- 2. Reinstate Respondent's paramedic certification with limitations placed upon the scope of Respondent's practice and/or conditional upon further reports to the Director.
- 3. Continue the suspension of Respondent's paramedic certification.
