

## Qhov Txheej Txheem Yuam Kev Kho Mob rau: Tus Neeg Tau Mos Deev Lwm Tus

### 1) Kuaj mob ua ntej ua ntawv foob thiab ua ntawv foob

---

- A. Ib tug neeg twg yeej hais tau lub zos county kom muaj ib qho kev soj ntsuam saib seb koj puas yuav tsum raug quab yuam kom muaj kev kho. Ua ntej muaj qhov txheej txheem ntawm rooj plaub qhuab yuav kev kho mob, cov kev tshwm sim muaj tseeb yuav tsum tau muab xa mus rau tus kws lij choj hauv lub zos county, yog tias nws, txaus siab tias yeej muaj tshwm sim, nws mam npaj ua daim ntawv foob. Tus kws lij choj hauv lub zos county **kuj yuav** xav kom tau daim ntawv qhia txog qhov kuaj ua ntej ua ntawv foob, tabsis mas tsis zoo ib yam li lwm qhov kev quab yuam kho mob, daim ntawv qhia txog qhov kuaj ua ntej ua ntawv foob no **tsis tas kom muaj** rau cov neeg raug quab yuam kho mob vim yog mos deev lwm tus.
- B. Yog tias tus kws lij choj hauv lub zos county txiav txim siab tias yuav tsum tau kuaj ua ntej ua ntawv foob, ces yuav teeb tsa ib pawg neeg kuaj.
- C. Pab neeg kuaj ua ntej ua ntawv foob no yuav muab cov ntaub ntawv kuaj koj los saib thiab yuav qhia txog lawv qhov kev xav tias yuav tsum tau ua li cas rau tus kws lij choj hauv lub zos county.  
Qhov no yog muaj xws li:
  - 1. ib tug neeg xav phaj koj; (xum kom yog tim ntsej tim muag)
  - 2. soj ntsuam txog cov lus tau iab liam tias vim li cas thiaj lis yuav tsum quab yuam kho mob;
  - 3. Nrhiav lwm txoj hauv kev kho mob es txog yog raug muab quab yuam, thiab
  - 4. Nrhiav cov ntaub ntawv los ntawm lwm tus neeg
- D. Txhua yam koj hais qhia rau tus neeg kuaj koj tej zaum muab tso nrog rau daim ntawv foob thiab tej zaum yuav siv thaum muaj rooj plaub sab laj.
- E. pab neeg kuaj mob ua ntej ua daim ntawv foob yuav qhia lawv qhov kev xav seb puas yuav muab koj quab yuam kho mob los tsis quab yuam.
- F. Tom qab tau txais qhov kev xav, tus kws lij choj hauv lub zos mam li txiav txim siab seb puas yuav ua ntawv foob los tsis ua kom quab yuam koj mus kho mob. Yog tias tus kws lij choj hauv lub zos county ntseeg tias qhov koj tau ua yeej poob rau qhov kev tshab txhais tias muaj tus cwj pwm vwm quab yuav deev lwm tus los yog muaj kev phom sij txog kev quab yuam deev lwm tus “sexual psychopathic personality” los yog “sexually dangerous person” raws li tshab txhais nyob hauv tsab cai [MN Statute § 253D.02](#), ces yuav ua ib daim ntawv foob.
- G. Daim ntawv foob yuav xa mus rau lub zos county es muaj kev lav phib xaub txog qhov them tus nqi los yog lub zos es tus neeg raug foob nyob tam sim no. Yog tias koj raug kaw hauv lub tsev kaw, daim ntawv foob yuav muab xa mus rau lub tsev hais plaub ntawm qhov chaw es muab lub txim txhaum rau koj.

### 2) Rooj Plaub Sab Laj Quab Yuam Kho

---

- A. Yog tias xa daim ntawv foob mus lawm, lub tsev hais plaub yuav tsa ib tug kws kuaj mob hauv lub tsev hais plaub tuaj kuaj koj thiab muab koj cov keeb kwm los saib. Thaum daim ntawv foob muab xa mus lawm, koj yeej muaj qee txoj cai, xws li muaj cai kom muaj ib tug kws lij choj pub dawb, teeb tsa los ntawm lub tsev hais plaub, muaj cai nrhiav lwm tus kws los kuaj koj zaum ob, muaj cai tuaj rau ntawm rooj plaub sab laj, thiab muaj cai tawm tsam qhov txheej txheem thiab muaj cai nrhiav cov pov thawj thiab cam cov pov thawj.
- B. Rooj plaub sab laj quab yuam kho mob yuav tsum tau tshwm sim tsis pub dhau 90 hnuv thaum daim ntawv foob xa mus. Nws kuj yuav raug tauj sij hawm ntxiv li 30 hnuv ntxiv yog tias muaj laj thawj zoo.

- C. Tus neeg kuaj mob hauv lub tsev hais plaub yuav tsum tau muab daim ntawv kuaj tag es sau qhia xa mus rau lub tsev hais plaub li 48 xuab moo ua ntej rooj plaub sab laj. Yog tias lub tsev hais plaub pom tau tias koj yog ib tug neeg muaj kev phom sij quab yuam mos deev lwm tus los yog muaj tus cwj pwm vim xav quab yuam deev lwm tus, lub tsev hais plaub yuav quab yuam kom mus kho rau Minnesota Sex Offender Program (MSOP).
- D. Koj tus kws lij choj muaj cai yog tus yuav tsum nrhiav kom muaj pov thawj qhia rau lub tsev hais plaub kom meej tseeb thiab kom ntseeg tias qhov chaw kho es coj tsis tshua nruj yeej muaj los kho qhov koj tau quab yuam mos deev lwm tus yog tias qhov quab yuam kho no tsis yog mus kho rau ntawm MSOP. Qhov chaw kho es coj tsis tshua nruj no yuav tsum kho koj kom kho yam cuag nua lis qhov yuav tsum tau kho koj thiab kom muaj kev thiv thaiv rau cov pej xeem thuaj pais.
- E. Qhov chaw MSOP yog ib qho program pab kho es muaj nyob rau ob qho chaw: Moose Lake thiab St. Peter. Tag nrho cov neeg mus kho pib kho ntawm lub chaw MSOP Moose Lake thiab tej zaum kuj muab hloov mus rau lub chaw ntawm St. Peter kom thiaj li kho kom tiav lug thiab pib qhov txheej txheem muab tshem tawm kev kho es mam li soj ntsuam.

### 3) Thaum Raug Quab Yuam Kho Mob Lawm

---

Yog tias lub tsev hais plaub pom tau tias koj yog ib tug neeg muaj kev phom sij quab yuam mos deev lwm tus los yog muaj tus cwj pwm vwm xav quab yuam deev lwm tus, lub tsev hais plaub yuav quab yuam kom mus kho yam tsis paub meej tias thaum twg mam kho tag. Tsuas yog pawg neeg tshwj xeeb (Special Review Board) thiaj li yog cov yuav los mloog txog tej yam koj xav hloov es muaj rau koj lawm.

### 4) Cov Nqi Kho

---

Yog tias koj raug quab yuam kho mob hauv qhovchaw es yog lub xeev yog cov tswj, cov nuj nqi kho koj tej zaum yuav xa tag nrho tuaj rau koj los yog xa ib feem ntawm qhov nqi tuaj rau koj. Thaum koj tseem muaj txoj sia nyob, qhov nqi nov yuav them raws li qhov koj them taus. Tom qab koj tag sim neej lawm, lub xeev muaj cai foob kom tau koj tej qub txeeq qub teg li vaj tse los them tag nrho cov nqi koj tiv.

Nws yeej yog ib qhov txheej txheem es lub tuam tsev Department of Human Services ceev ib co nyiaj ntawm koj txoj hauj lwm koj khwv tau thaum koj tseem kho mus them rau cov nqi kho koj.

### 5) Muaj Feem Xyuam Dabtsi Txog Txoj Cai Thaum Raug Quab Yuam Kho Mob

---

- A. Ib tug neeg raug quab yuam kho mob es yog tus neeg muaj kev phom sij quab yuam mos deev lwm tus los yog vwm xav quab yuam deev lwm tus kuj yuav muaj kev cuam tshuam txog qhov muaj daim ntawv tso cai xws li professional los yog personal licenses. Tiv tauj lub chaw ua hauj lwm los yog cov neeg tswj daim ntawv tso cai es yog cov muab daim ntawv tso cai (license) rau koj kom paub ntau dua.
- B. Cov ntaub ntawv ceev cia hauv lub tsev hais plaub txog rooj plaub quab yuam kho mob mas yog cov ntaub ntawv pub rau txhua tus pom. Qee yam nyob hauv cov ntaub ntawv kuj yuav muab kaw tsis pub neeg paub, tabsis qhov tias koj yeej raug quab yuam mus kho yeej yog cov ntaub ntawv rau txhua tus pom.

### 6) Quab Yuam Kev Kho Mob muaj Ob Lub Hom Phiaj

---

- A. Kom muaj kev pab rau cov neeg es lub tsev hais plaub tau txiav txim xav kom yuav tsum tau mus kho qhov tau quab yuam deev lwm tus es lub hom phiaj yog txo kom tsis txhob rov muaj tej yam li qub tshwm sim lawm, thiab
- B. Los tiv thaiv cov pej xeem thuaj pais kom tsis txhob muaj tej kev quab yuam mos deev.
