Special Education Licensure Advisory Group: Overview & Charge

2018 Special Education License Review Work Group & Report

2024 Legislative Work Group

- Work group created by 2024 Legislature to review all special education licensure statutes and rules and make recommendations on how to streamline licensure process
- Work group consisted of special education teachers, administrators, teacher preparation providers, Education Minnesota
- Reviewed tiered licensure and current special education licenses, looked at other states' SPED licenses and reviewed SPED teacher data in Minnesota
- Legislative Report submitted on February 1, 2025

Special Education Licensure Advisory Group: Overview & Charge

2024 Legislative Work Group Recommendations

- Create an ABS (cross-categorical) moderate/severe license
- Move to two main special education licenses (ABS for mild/moderate needs and new moderate/severe license)
- Keep low incident special education areas (DHH, BVI, DAPE and ECSE)

2025 Board Subcommittee

At the January 2025 Board meeting, the Board authorized a Special Education Licensure Subcommittee to review the Special Education Workgroup's Recommendations in their report to the Legislature, published on February 1, 2025. That group determined more input was needed, so the Special Education Licensure Advisory Group was formed.

Charge: Review policy and research related to special education licensure and make a recommendation on the creation of a new moderate to severe cross-categorical license.

Special Education Licensure Advisory Group

Call to Order

Recommendation:

- The group was split on the recommendation.
- Of the half that do not want changes to the license, 2 of 3 people recommend the Board pursue 2 cross-categorical, moderate-to-severe licenses (behavioral and developmental) *if* the Board decides to combine licensure areas.
- The majority recommend not replacing the Physical and Health Disabilities License.
- *If* the Board pursues a cross-categorical license, renewal requirements should include specialized training.

Concerns:

- Several group members did not attend meetings, limiting input.
- Too much of the burden may fall on districts. What if they don't have the resources?
- While surveyed ABS teachers feel they are more prepared than their colleagues think they are, about half of do not feel adequately prepared.
- Unclear this will address retention or shortage concerns.
- What would the scope of new licenses be?

December 2024 Board authorized a two-year pilot allowing use of the CPAST performance assessment.

Pilot goal: To collect data on an alternative performance-based measure of teacher preparation.

- Pilot began in Spring 2025
- Data availability and analysis is limited based on only one semester of active implementation.
- How does the CPAST support PELSB in meeting its regulatory obligations and does its use align to PELSB's mission and vision? What data will be needed to answer questions about its possible long-term use.

Board Professional Learning Topic, January 22, 2026

- **Current National Landscape**

- Microcredentials have been growing in education and related fields.
- The National Education Association offers microcredentials, as do institutions of high education, and non-profit and for profit businesses.
- Some states are beginning to enact policies around microcredentials.

Given the increased interest and use of microcredentials the board needs to consider how to set direction in this area related to licensure. This work aligns with the board's focus on the future of licensure.

Draft bill language for the 2026 session is being written for a Microcredential Task Force. The purpose of the task force would be to consider the benefits of teacher microcredentials and how they can be implemented in Minnesota. As the bill is currently drafted PELSB's executive director would lead this effort.

The board should consider adding this to the legislative platform enabling the executive director to speak to it during session.
