1. The Executive Director of the Professional Educator Licensing and Standards Board is authorized and directed to sign and to give the Notice of the Board's Intent to Adopt Rules after holding a public hearing in the Revisor of Statutes draft, file number 4615, dated 12/16/21, with any modifications approved by the Board. The Executive Director must give this notice to all persons who have registered their names with the Board for that purpose. The Executive Director must also publish the Notice in the State Register. Furthermore, the Executive Director is authorized and directed to do anything else needed to complete this Notice.
2. The Executive Director of the Professional Educator Licensing and Standards Board is authorized and directed to act as the Board's representative at the hearing and do anything else needed to adopt these rules with a hearing. This includes authority to sign the Order Adopting Rules if there are no modifications to the rules other than modifications approved by the Board.
