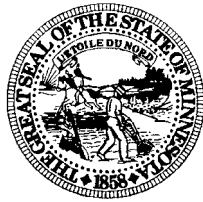

### **Approval of the Agenda:**

### **Approval of the Minutes: Review:**

  - a. Intent

1. Adopt an 'Excessive Force Standard' into the standard of conduct.

- b. Statutory Authority

- i. MN STAT 626.843 RULES, STANDARDS; EXECUTIVE DIRECTOR.

- ii. MN STAT 609.06 AUTHORIZED USE OF FORCE.

c. Draft Language

- i. **Minnesota Rule 6700.1600 (L):** using deadly force when not authorized by Minnesota Statutes, section 609.066 or using excessive force when not authorized by Minnesota Statutes section 609.06;

2. Removing the Conviction Requirement from the Standard of Conduct Rule Draft

a. Intent

- i. Remove a conviction requirement for any offense from the standard of conduct.

b. Statutory Authority

- i. MINN STAT 626.843 RULES, STANDARDS; EXECUTIVE DIRECTOR.

c. Draft Language

- i. Minnesota Rule 6700.1600 (Q): engaging in conduct considered a crime. as defined by Minnesota Statutes. section 609.02. that is listed grounds for disciplinary action under this chapter. Notwithstanding conviction.

d. Suggested Amendment

- j. Minnesota Rule 6700.1600 (Q): engaging in conduct considered a crime. as defined by Minnesota Statutes. section 609.02. that is listed grounds for disciplinary action under this chapter.. Whether or not licensee is prosecuted or convicted.
