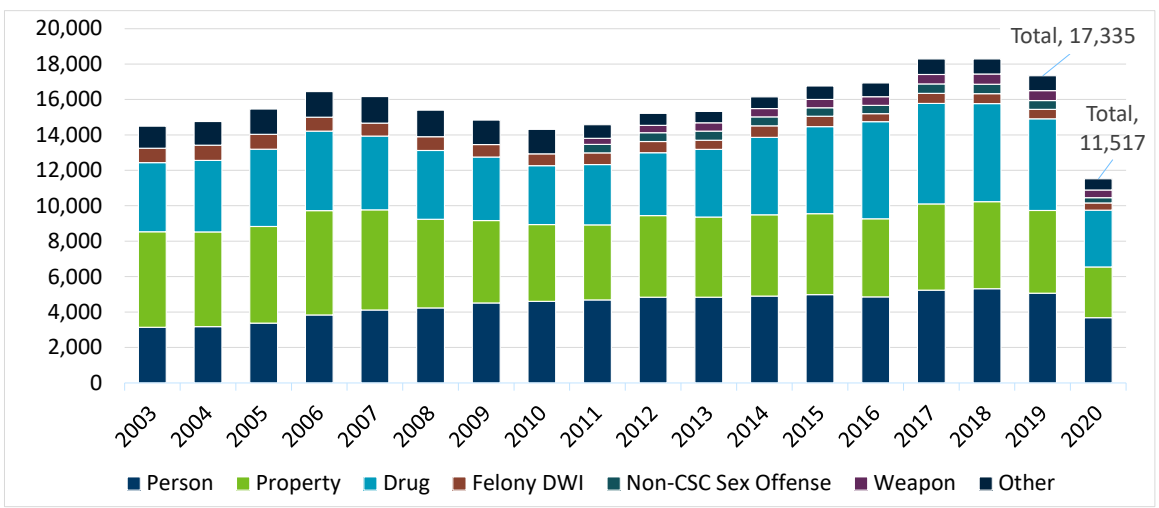

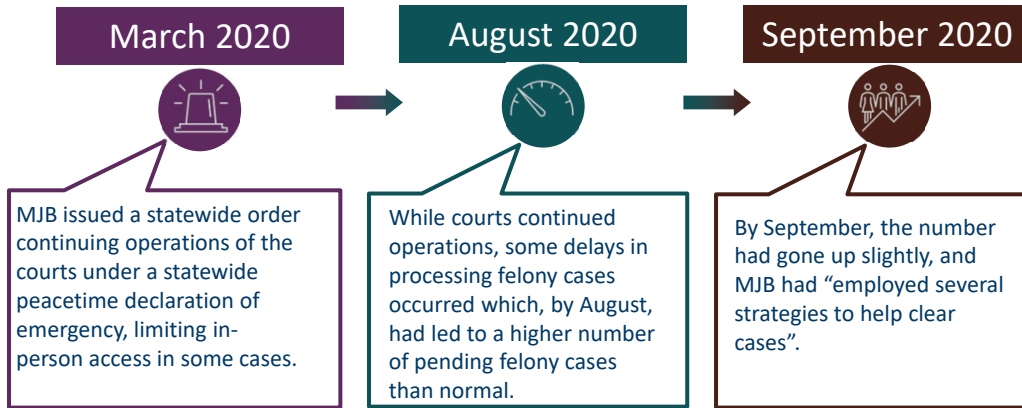

Pandemic Impacts on 2020 Sentencing Data

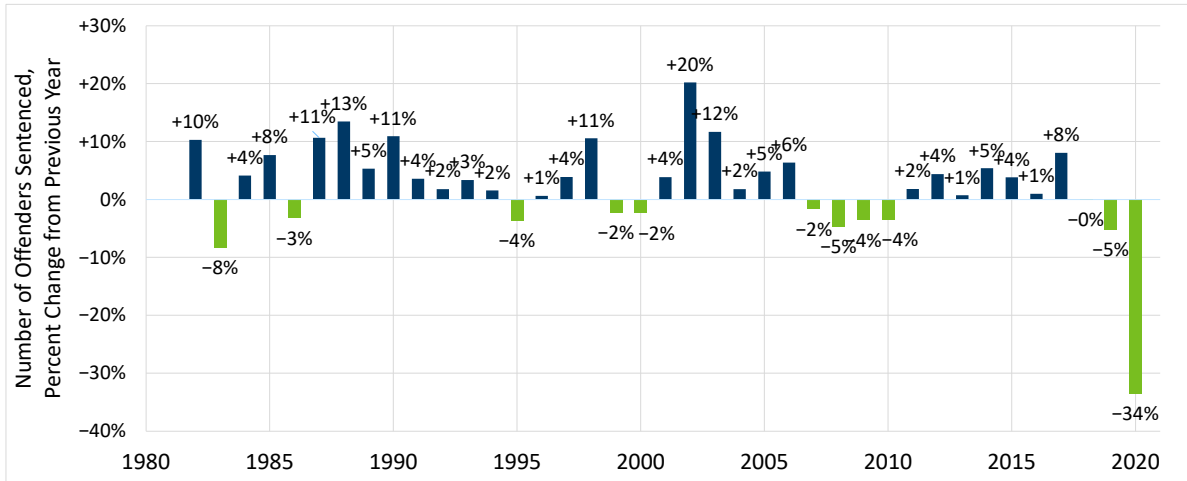
Case volume data in 2020 are not typical and should be reviewed in that context.

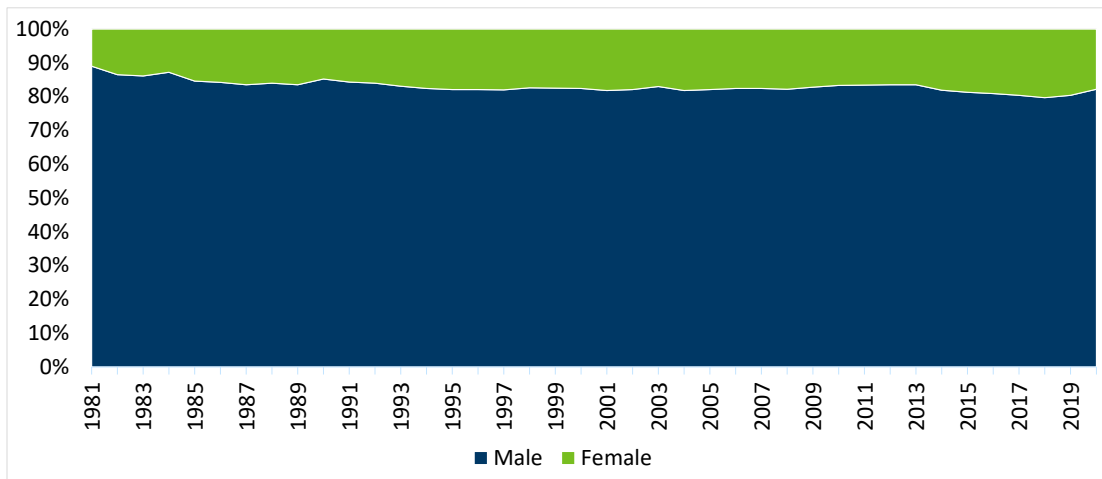

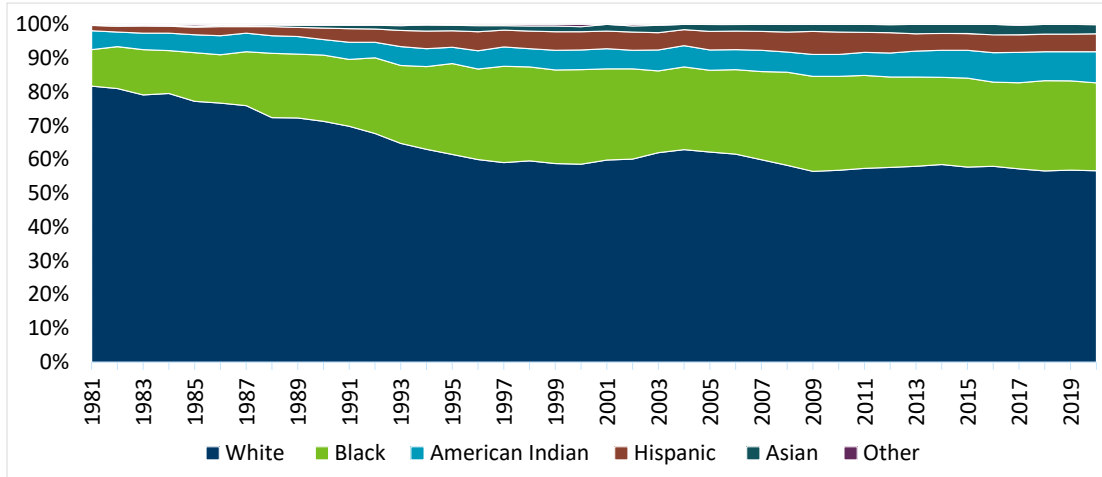
Distribution of Offenders by Gender, 1981-2020

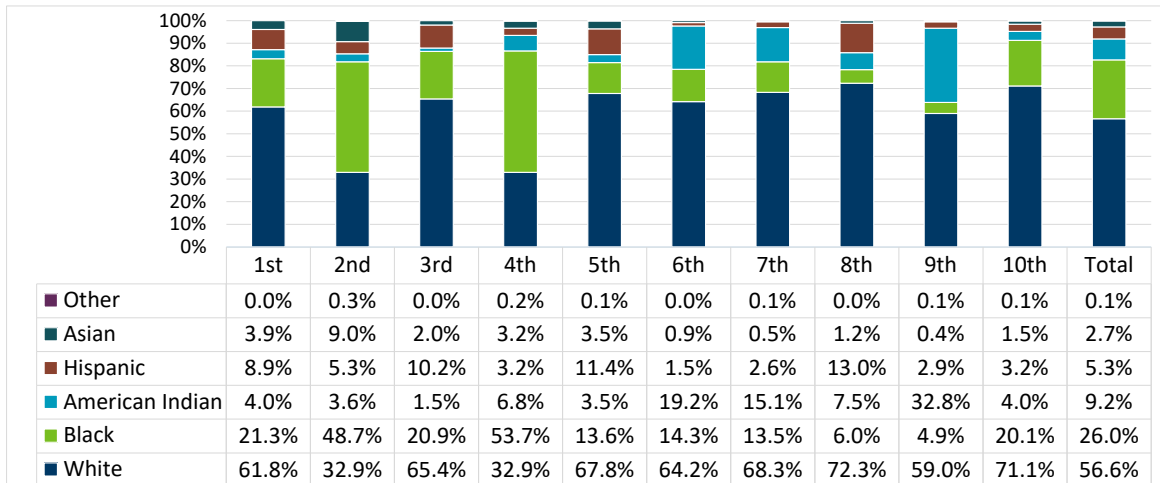
Distribution of Offenders by Race/Ethnicity, 1981-2020

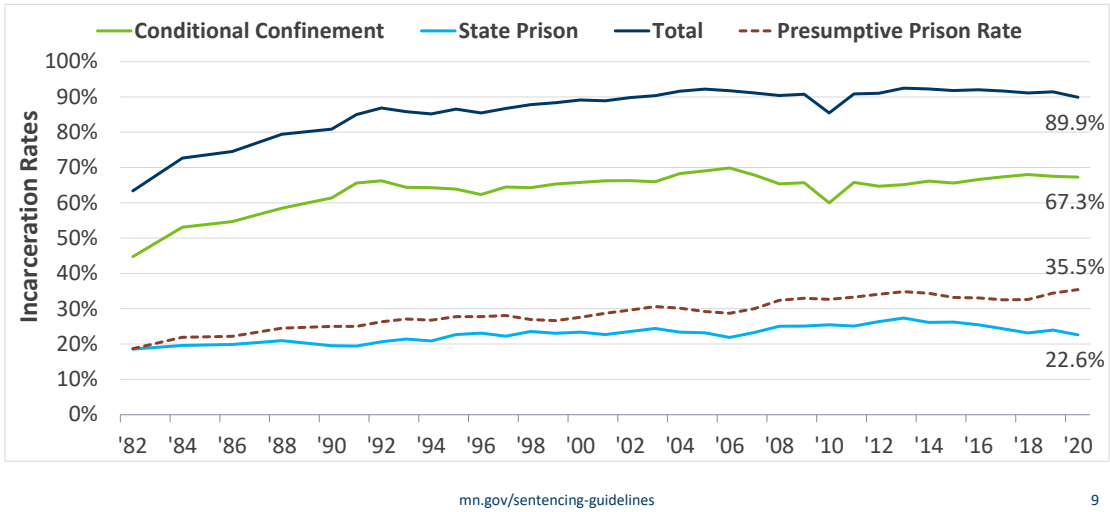
Distribution of Felony Offenders by Race and Judicial District, 2020



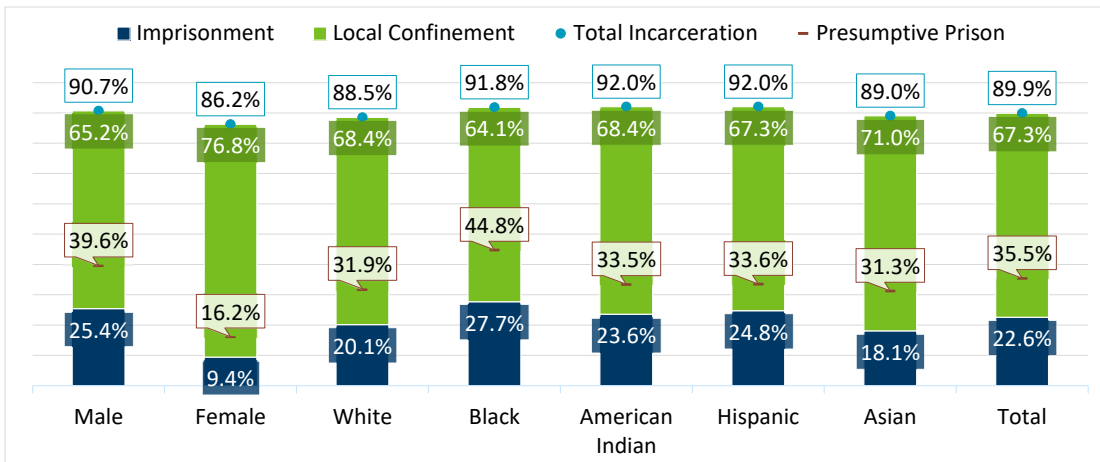

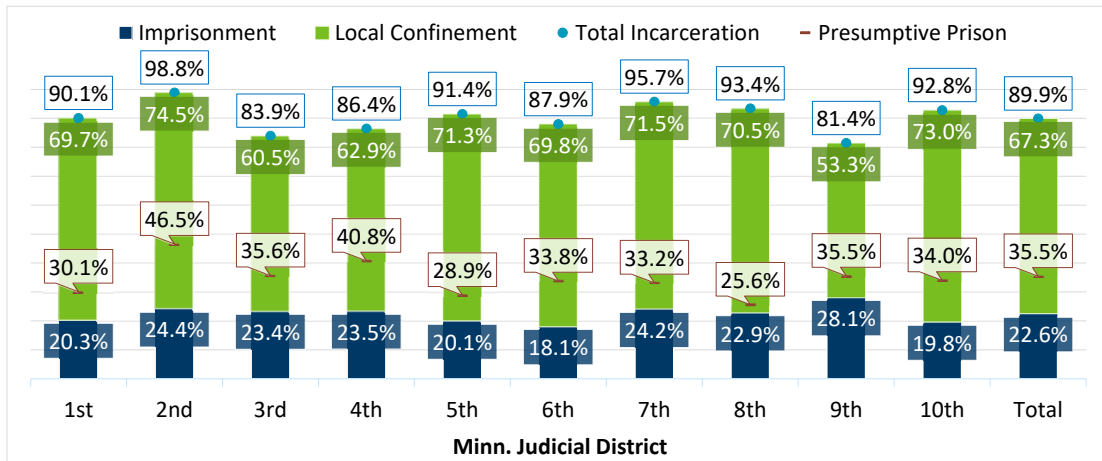
Total Incarceration Rates, 1982, 1984, 1986, 1988-2020



Incarceration Rates by Gender & Race/Ethnicity, 2020



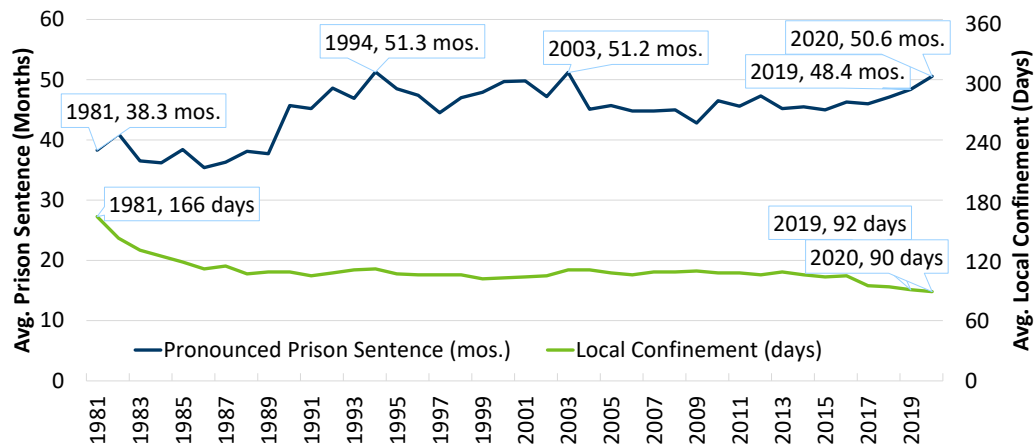
Incarceration Rates by Judicial District, 2020

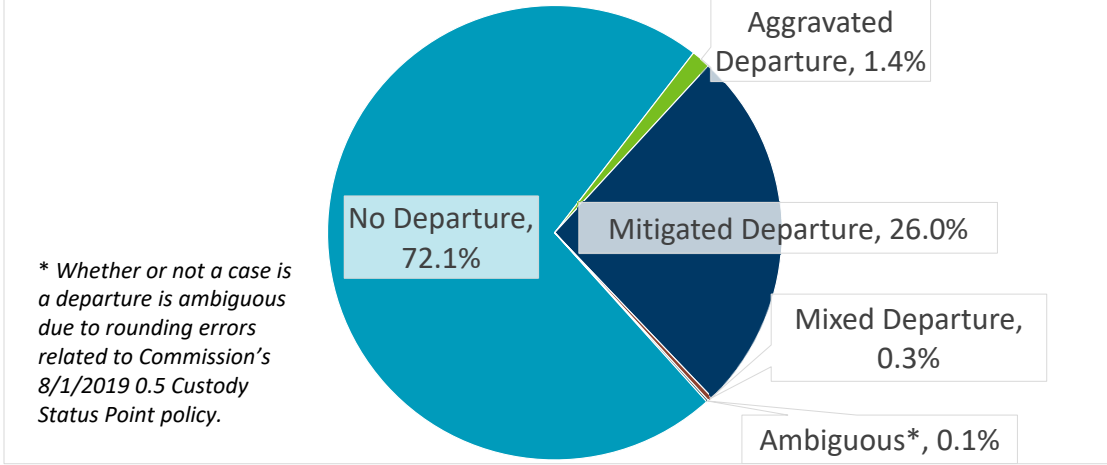
Average Pronounced Prison Sentences and Confinement in a Local Correctional Facility, 1981-2020

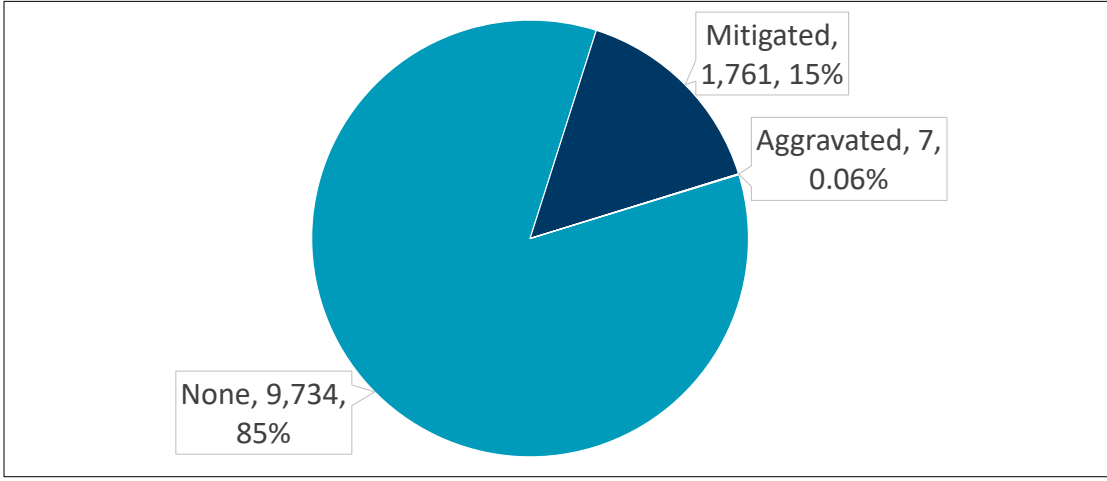
Total Departure Rates, 2020

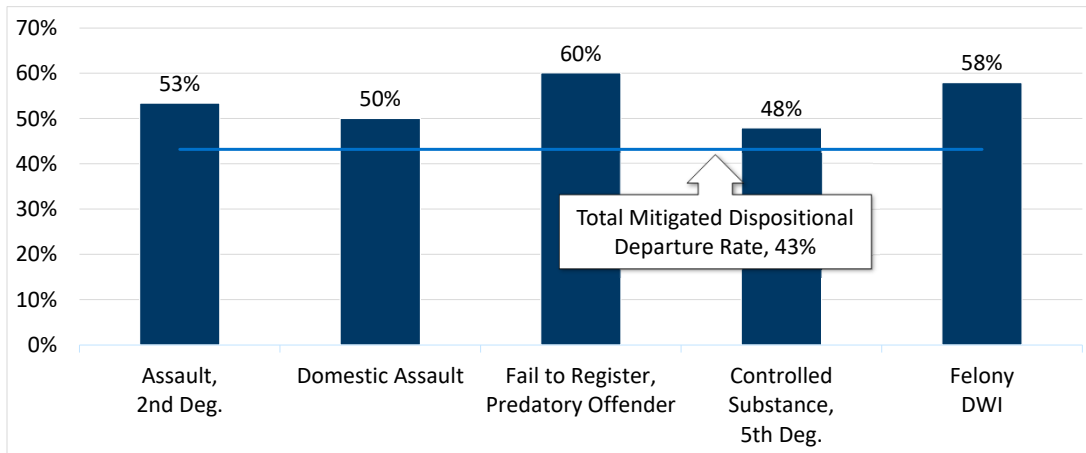
Dispositional Departure Rates, 2020

Mitigated Dispositional Departure Rates for Presumptive-Commit Cases, Selected Offenses Compared to Total, 2020

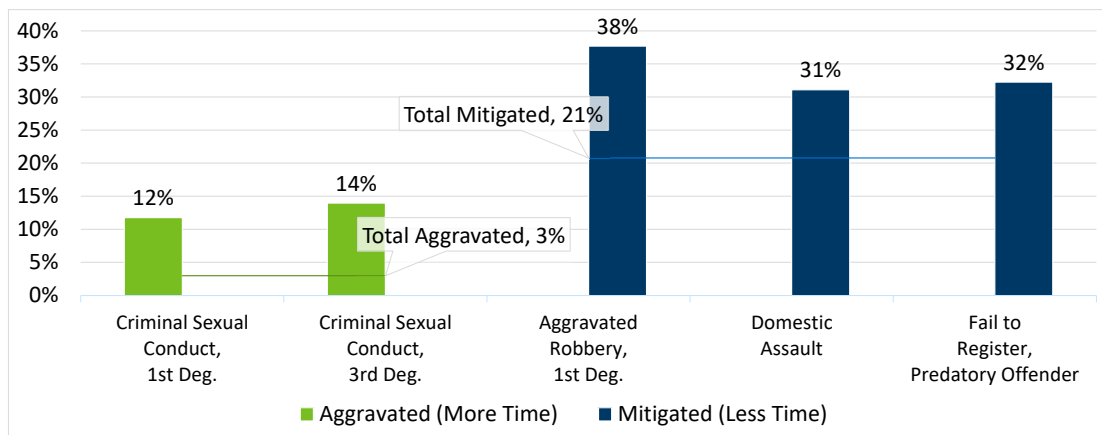


Offenses were selected based on criteria that there were 50 or more presumptive commitment cases and the mitigated dispositional departure rate was 48 percent or more.

Durational Departure Rates Among Cases Receiving Executed Prison Sentences, Selected Offenses cf. Total Rates, 2020

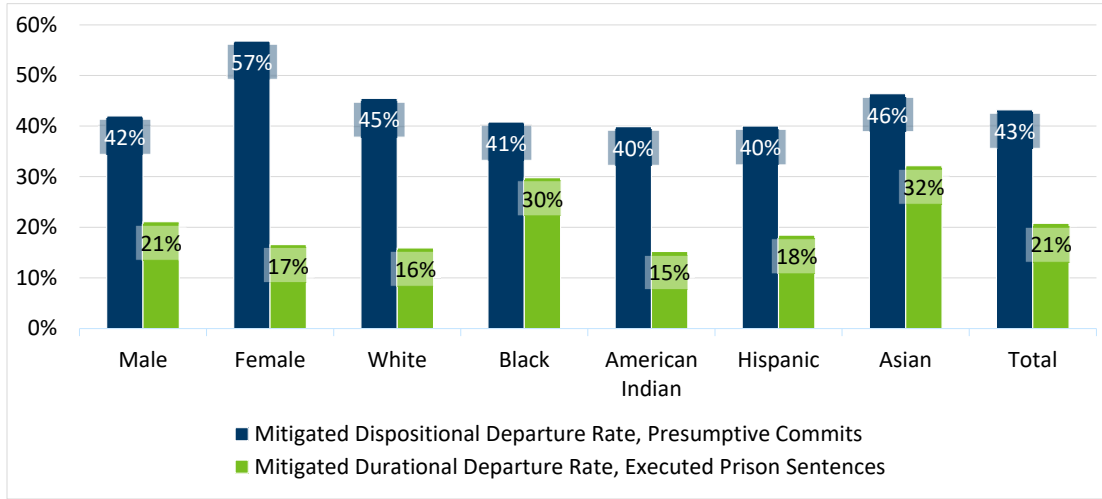

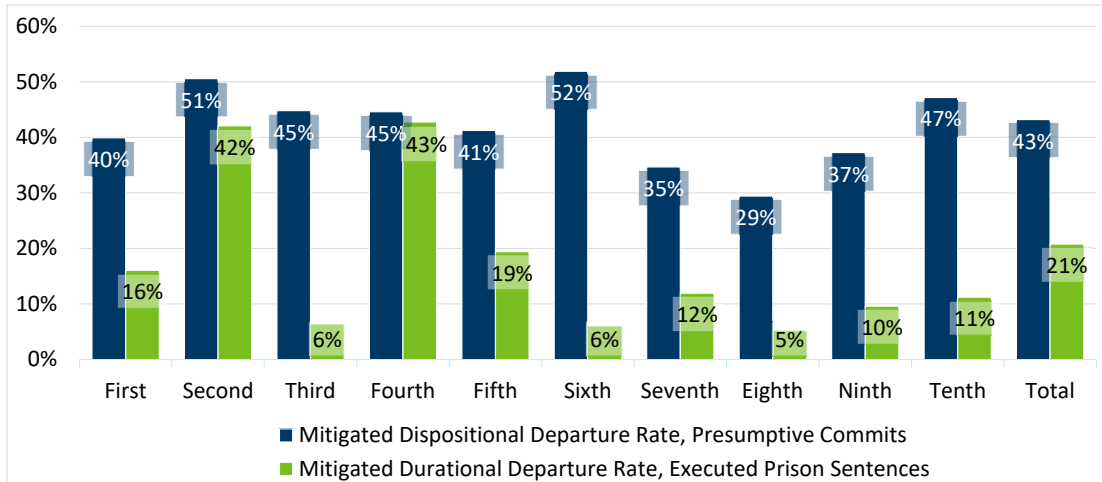
Mitigated Departures by Gender & Race/Ethnicity, 2020

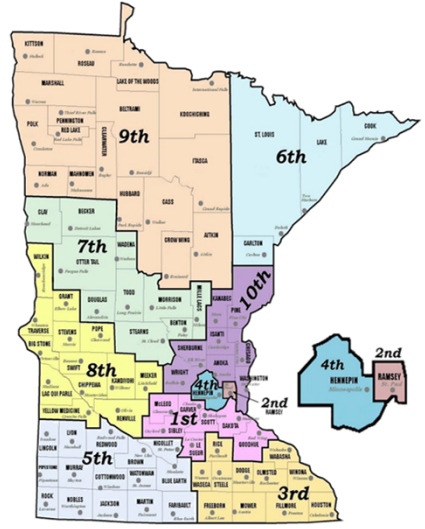
Mitigated Departures by Judicial District, 2020
