Hello,

As a nonpartisan employee of the House, I take no position on the substance of the proposed changes. But I wanted to flag one suggested change that may include an oversight or unintended consequence.

On page 28, the proposal includes a new mitigating factor. Under the proposal, it could be a mitigating factor that a person has "no prior criminal conviction or stay of adjudication." The proposal does not mention juvenile adjudications. As a result, the mitigating factor could apply when the person has a juvenile adjudication but would not apply when the person received a stay of adjudication for a juvenile offense.

In other words, the less severe juvenile outcome (a stay of adjudication) disqualifies a person from this mitigating factor while the more severe juvenile outcome (an adjudication) does not. I do not believe that this is what the commission intends.

Again, I take no position as to whether the commission should add juvenile adjudications to the list of disqualifying outcomes or limit the provision to adult sentences.
