SECTION 2 – SUMMARY OF SCOPE

1. Solicitation Overview, Goals, and Background.

This Request for Proposal (RFP) is for the facilitation and replication of "Ambassadors For Respect" - An Anti-Bullying Program to Strengthen Self-Advocacy (A4R). The A4R program has been designed for Self Advocates or transition students with disabilities, including individuals from diverse racial and ethnic communities, to take the lead in teaching and training elementary school children about self-advocacy, and how to deal with and address bullying issues.

The current Five Year State Plan for the Minnesota Governor's Council on Developmental Disabilities (GCDD) has been submitted to the Administration for Community Living (ACL), US Department of Health and Human Services for FFYs 2022-2026. The Plan includes the following goal statement regarding Self-Advocacy:

"Support opportunities for individuals with developmental disabilities who are considered leaders to provide leadership training to individuals with developmental disabilities who may become leaders."

Funding is provided to the State of Minnesota as authorized under the Developmental Disabilities Assistance and Bill of Rights Act of 2000 (DD Act)(P.L. 106-402). This project is 100% supported by the ACL. The contents of the grant project are those of the author(s) and do not necessarily represent the official views of, nor an endorsement, by ACL/HHS, or the U.S. Government. These federal funds are allocated by the Governor's Council on Developmental Disabilities (GCDD).

The A4R program was initiated in 2013 by Merrick, Inc. as an anti-bullying program researched by several Merrick "Shooting Stars" self-advocates. It has continued as a grant program of the GCDD with different leadership to replicate the program as "Ambassadors for Respect" after the death of the Merrick program coordinator in 2017.

Transition students and other adults with disabilities present the educational training to fourth grade students. The purpose of the A4R program remains to strengthen self-advocacy for individuals with developmental disabilities and to strengthen bullying prevention efforts in fourth grade classrooms through trainings about inclusion, using Person First Language, and topics such as acts of kindness and identity-first language, as well as being an advocate for oneself and others.

Initially, only in-person delivery in a classroom approach was used. The pandemic led to increased use of video to deliver the training. Both approaches will continue in the future as video training allows for the use in classrooms that are not necessarily located close to transition program partners who provide the training. There is a powerful impact when the training is presented by self advocates and students with disabilities in transition who have experienced bullying first-hand.

During the 2021-2022 school year, the A4R program worked with seven different partner transition programs who trained Ambassadors to provide education in fourth grade classrooms. The partner programs were located in St. Paul, Vadnais Heights, North St. Paul, St. Cloud, Willmar, Mounds View, and Eden Prairie, Minnesota.

- 100% of Ambassadors responded that they are satisfied with the A4R Program.
- 94% of Ambassadors reported that, due to participation in the program, they are better able to say what they want, and what is important to them.
- 878 fourth grade elementary students participated in A4R trainings, in 19 schools, in 45 classrooms.

• 96% of teachers responded that they would like their class to receive an Ambassadors for Respect training next year.

A total of **\$40,000** in federal funds is anticipated to be available to support an annual replication of the Ambassadors for Respect program.

2. Who Can Apply.

Proposals can be submitted by any public organization, private for profit business, or private non-profit organization that has 501(c)(3) tax-exempt status from the Internal Revenue Service. Applicants must include a document confirming their status.

Respondents should demonstrate the following desired skills in their proposal:

- Awareness, knowledge, and understanding of the prevalence of bullying; the impact on students who
 experience bullying, including students with disabilities and students from diverse racial and ethnic
 communities; the benefits of addressing the issue with elementary school students; and equipping all
 students with the knowledge and skills to protect themselves and address negative behaviors.
- Knowledge and experience in self advocacy or advocating with people with developmental disabilities as well as individuals from diverse racial and ethnic communities.
- Knowledge and experience with leadership development, leadership training, and promoting self advocates as leadership trainers.
- Experience in collecting and reporting training session data, and how data are used to improve the quality of a training program.
- Experience in working with other organizations to promote a program or service, and fostering positive partnerships with the leadership to maximize the outcomes/results for a target audience.

3. Evaluation and Reporting.

GCDD goals focus on providing information, education, and training to build knowledge, develop skills, and change attitudes so that people with developmental disabilities and their families will increase their Independence, Productivity, Self Determination, Integration and Inclusion (IPSII). These terms are found in the DD Act, and described further in **Section 8 – Definition Of Terms.** Speakers or presenters also evaluate themselves in terms of IPSII.

IPSII results for transition students and adults who are Ambassadors for Respect and federally mandated Administration for Community Living (ACL) outcome and output Performance Measures surveys must be collected by awarded Responder. Copies of sample surveys are attached as **Exhibits B and C.**

SECTION 3 – PROPOSAL INSTRUCTIONS AND ADDITIONAL INFORMATION

1. Anticipated Contract Term and Quality Improvement Budget.

The initial term of this contract is anticipated to be from July 2023 to June 30, 2024. A contract resulting from this RFP process may be renewed for up to four additional years.

The budget for this workplan in this proposal should be **\$40,000.00**. Continuation funding in subsequent years and the level of funding is dependent upon the availability of federal funds and satisfactory performance of the grantee.

2. Question and Answer Instructions.

All questions should be submitted in writing to the contact person via email and by the date and time listed in Section 1, Instructions to Responders. The State is not obligated to answer questions submitted after the question due date and time. The contact person will post the questions and written answers on the GCDD website (https://mn.gov/mnddc/council/rfp-grants.html) as well as send a written response to all who submitted written questions.

Only the contact person is authorized to discuss this solicitation with responders. Contact regarding this solicitation with any other GCDD or State personnel could result in disqualification. This provision is not intended to prevent responders from seeking guidance from state procurement assistance programs regarding general procurement questions.

If a Responder discovers any significant ambiguity, error, conflict, discrepancy, omission, or other deficiency in the solicitation, please immediately notify the contact person detailed above in writing of such error and request modification or clarification of the document.

3. Sample Contract.

Please review the State's Standard Terms and Conditions in the Sample Grant Contract attached as Exhibit A. The State reserves the right to reject any additional terms and conditions proposed within transaction documents.

4. A4R Program Resources

An Ambassadors for Respect Handbook has been created along with The Ambassadors for Respect Teacher Resource Guide. Both of these resources were updated by PeaceMaker Minnesota. Links to both of these resource materials can be found on the Publications - Resources page found on the GCDD website at https://mn.gov/mnddc/extra/publications.html. These publications should be thoroughly reviewed and referred to when preparing a proposal.

5. Project reporting.

The successful grantee will prepare and submit narrative and financial reports on a monthly basis to the GCDD that reflect the completion of, or progress being made in achieving, all performance goals specified in the Grant Contract. A face to face performance review with the Grant Review Committee or a presentation at a regular GCDD Council meeting will occur annually.

6. State partnership.

The successful grantee will work with GCDD staff on an ongoing basis to discuss training session planning details and overall program implementation; assure that performance goals and reporting requirements are met (both program and financial), and expenditures are in keeping with the approved budget; and that the core values and concepts of the Baldrige Framework and similar quality principles are utilized in replicating the A4R program. The GCDD will expect the grantee to be mindful of process improvements that will increase the efficiency and effectiveness of the program and increase IPSII results for A4R participants.

SECTION 4 – PROPOSAL CONTENT

Please submit the following information:

- **1.** <u>Program Narrative</u>. (*This section should be no more than 10 pages in 11-point font size or larger*). Clearly address the following in your Proposal Narrative in order to obtain maximum evaluation points.
 - 1.1. Describe your Knowledge, and understanding of the prevalence of bullying; the impact on students with and without disabilities, and students from diverse racial and ethnic communities who experience bullying; and the benefits of providing all students with the knowledge and skills to protect themselves and address negative behaviors. (10 points).
 - 1.2. Develop a work plan for carrying out the Ambassadors for Respect program using the *Ambassadors* for Respect Handbook, including planning and preparing presentations, presentation materials for related activities, accessibility and accommodations, and timelines for completing all work. (15 points).
 - 1.3. Do you have any current partnerships/relationships with elementary schools and how will you market and promote the Ambassadors for Respect program with school leadership to arrange training sessions with 4th grade students?. What approaches will you use to recruit adults with disabilities who have experienced bullying to present training in classrooms? How will you help them to develop and strengthen their presentation? How will you grow the program in greater Minnesota so that at least 30% of presentations are outside the seven-county metro area? (15 points).
 - 1.4. What is your understanding of IPSII? How will training session evaluation performance measures data be collected and used to improve the quality of the training program and increase IPSII results? (10 points).
- 2. <u>Diversity and Inclusion</u>. What is your plan to include 4th grade classes and self-advocates from diverse racial and ethnic or other marginalized communities who experience bullying? How will your workplan ensure that all participants are served in a culturally competent and accessible manner? (*Please include a copy of your organization's diversity plan, if you have one*). **(20 points).**
- **3.** <u>Performance Measures</u>. (*Limit this section to no more than two (2) pages*). How will you collect and report training session evaluation data from classroom students as well as Ambassador presenters. How will you use data on ACL performance measures and IPSII outcome measures to improve the quality of the training program and increase IPSII results? (10 points).
- 4. Resumes and References. Submit *resumes* of key project staff as Attachment D. Resumes or other information about project personnel should not, if possible, contain personal telephone numbers, home addresses or home email addresses. Responder should complete and submit "Attachment E: References Form Template" with their response. Responder should submit *two completed reference forms* answering every question. The State reserves the right to verify the information received by contacting the Responder's reference. (10 points).
- **5.** <u>Budget and Budget Justification</u>. Complete and submit **Attachment F**, "Budget Form." Complete a proposed Budget according to the line item categories on the Budget Form. The Budget Justification explains the costs allocated under each major line item. **(10 points).**

The GCDD encourages Responders to specify compensation or stipends for Ambassadors' effort is equivalent to minimum wage or higher. **Five (5) preference points** will be added for proposals that specify that trained presenters will be compensated at minimum wage levels or higher.

The budget must include a twenty-five (25) percent local match. Local match can be generated by volunteer hours of participants as well as in-kind direct and indirect expenses.

6. Financial Review Process.

All Non-Governmental Organizations (NGOs) applying for grants in the state of Minnesota must undergo a financial review prior to a grant award made of \$25,000 and higher. (*Most NGOs are non-profit organizations*).

In order to comply with State <u>Policy 08-06</u>, Financial Review of Nongovernmental Organizations, please submit one of the following documents with your application, based on the following criteria:

- Grant applicants with annual income of under \$50,000, or who have not been in existence long enough to have a completed IRS Form 990 or audit should submit their most recent board-reviewed financial statements.
- Grant applicants with total annual revenue of \$50,000 or more and less than \$750,000 should submit their most recent IRS Form 990.
- Grant applicants with total annual revenue of over \$750,000 should submit their most recent certified financial audit.

SECTION 5 – EVALUATION PROCEDURE AND CRITERIA

The State will conduct an evaluation of responses to this Solicitation. The evaluations will be conducted in three phases:

Phase 1 - Review responses for responsiveness and pass/fail requirements

Phase 2 - Evaluate responses

Phase 3 - Select finalist

1. Phase 1 – Responsiveness and Pass/Fail Requirements

The purpose of this phase is to determine if each response complies with mandatory requirements. The State will first review each proposal for responsiveness to determine if the Responder satisfies all mandatory requirements. The State will evaluate these requirements on a pass/fail basis.

Mandatory Requirements. The following will be considered on a pass/fail basis:

• Responses must be received by the due date and time specified in this RFP.

2. Phase 2 - Evaluate Responses

Only those responses found to have met Phase 1 criteria will be considered in Phase 2. The GCDD's Grant Review Committee (Committee) reviews proposals sent in response to this RFP. Committee members will make a funding recommendation to the full council (GCDD).

The factors and weighting on which responses will be evaluated are (Refer to Proposal Content on pages 9-10):

1.	Program Narrative	50 points
2.	Diversity and Inclusion	20 points
3.	Performance Measures Evaluation	10 points
4.	Resumes and References	10 points
5.	Budget	10 points

6. Minimum Wage Preference Points +5 points (in addition to 100 available)

3. Phase 3 - Select Finalist

Only those responses that have been evaluated under Phase 2 shall be eligible for Phase 3.

The State will make its selection based on best value, as determined by this evaluation process. The State reserves the right to pursue negotiations on any exception taken to the State's standard terms and conditions. In the event that negotiated terms cannot be reached, the State reserves the right to terminate negotiations and begin negotiating with the next highest scoring responder or take other actions as the State deems appropriate.

SECTION 6 – SOLICITATION TERMS

1. Competition in Responding

The State desires open and fair competition. Questions from responders regarding any of the requirements of the Solicitation must be submitted in writing to the contact person listed in the Solicitation before the due date and time. If changes are made the State will issue an addendum.

Any evidence of collusion among responders in any form designed to defeat competitive responses will be reported to the Minnesota Attorney General for investigation and appropriate action.

2. Addenda to the Solicitation

Changes to the Solicitation will be made by addendum with notification and posted in the same manner as the original Solicitation. Any addenda issued will become part of the Solicitation.

3. Data Security - Foreign Outsourcing of Work is Prohibited

All storage and processing of information shall be performed within the borders of the United States. This provision also applies to work performed by subcontractors at all levels.

4. Joint Ventures

The State allows joint ventures among groups of responders when responding to the solicitation. However, one responder must submit a response on behalf of all the others in the group. The responder that submits the response will be considered legally responsible for the response (and the contract, if awarded).

5. Withdrawing Response

A responder may withdraw its response prior to the due date and time of the Solicitation. A responder may withdraw its response by notifying the Solicitation Administrator (contact person) in writing of the desire to withdraw.

After the due date and time of this Solicitation, a responder may withdraw a response only upon showing that an obvious error exists in the response. The showing and request for withdrawal must be made in writing to Solicitation Administrator within a reasonable time and prior to the State's detrimental reliance on the response.

6. Rights Reserved

The State reserves the right to:

- Reject any and all responses received;
- Waive or modify any informalities, irregularities, or inconsistencies in the responses received;
- Negotiate with the highest scoring Responder[s];
- Terminate negotiations and select the next response providing the best value for the State;
- Consider documented past performance resulting from a State contract may be considered in the evaluation process;
- Short list the highest scoring responders;
- Require Responders to conduct presentations, demonstrations, or submit samples;
- Interview key personnel or references;
- Request a best and final offer from one or more responders;
- The State reserves the right to request additional information; and
- The State reserves the right to use estimated usage or scenarios for the purpose of conducting pricing evaluations. The State reserves the right to modify scenarios, and to request or add additional scenarios for the evaluation.

7. Responses are Nonpublic during Evaluation Process

All materials submitted in response to this Solicitation will become property of the State. During the evaluation process, all information concerning the responses submitted will remain private or nonpublic and will not be disclosed to anyone whose official duties do not require such knowledge. Responses are private or nonpublic data until the completion of the evaluation process as defined by Minn. Stat. §§ 13.591 and 13.599. The completion of the evaluation process is defined as the State having completed negotiating a contract with the selected responder. The State will notify all responders in writing of the evaluation results.

8. Trade Secret Information

- 8.1 Responders must not submit as part of their response trade secret material, as defined by Minn. Stat. § 13.37.
- 8.2 In the event trade secret data are submitted, Responder must defend any action seeking release of data it believes to be trade secret, and indemnify and hold harmless the State, its agents and employees, from any judgments awarded against the State in favor of the party requesting the data, and any and all costs connected with that defense.
- 8.3 The State does not consider cost or prices to be trade secret material, as defined by Minn. Stat. § 13.37.
- 8.4 A responder may present and discuss trade secret information during an interview or demonstration with the State, if applicable.

9. Conditions of Offer

Unless otherwise approved in writing by the State, Responder's cost proposal and all terms offered in its response that pertain to the completion of professional and technical services and general services will remain firm for 180 days, until they are accepted or rejected by the State, or they are changed by further negotiations with the State prior to contract execution.

10. Award

Any award that may result from this solicitation will be based upon the total accumulated points as established in the solicitation. The State reserves the right to award this solicitation to a single Responder, or to multiple Responders, whichever is in the best interest of the State, providing each Responder is in compliance with all terms and conditions of the solicitation. The State reserves the right to accept all or part of an offer, to reject all offers, to cancel the solicitation, or to re-issue the solicitation, whichever is in the best interest of the State.

SECTION 7 – GRANT PROVISIONS

Conflicts of Interest

State grant policy requires that steps and procedures are in place to prevent individual and organizational conflicts of interest, both in reference to applicants and reviewers per Minn. Stat.§16B.98 Subd. 2-3 and 08-01 Conflict of Interest in State Grant-Making Policy.

Organizational conflicts of interest occur when:

- a grantee or applicant is unable or potentially unable to render impartial assistance or advice to the Department due to competing duties or loyalties
- a grantee's or applicant's objectivity in carrying out the grant is or might be otherwise impaired due to competing duties or loyalties

In cases where a conflict of interest is in question or disclosed, the applicants or grantees will be notified and actions may be pursued, including but not limited to, revising the grant work plan or grantee duties to mitigate the risk, requesting the grant applicant to submit an organizational conflict of interest mitigation plan, disqualification from eligibility for the grant award, amending the grant, or termination of the grant contract agreement.

Grant Provisions

A sample grant contract agreement template is attached for review as Exhibit A.

Ineligible expenses include, but are not limited to:

- Fundraising
- Taxes, except sales tax on goods and services
- Lobbyists, political contributions
- Bad debts, late payment fees, finance charges, or contingency funds
- Parking or traffic violations
- Out of state transportation and travel expenses. Minnesota will be considered the home state for determining whether travel is out of state.

Accountability and Reporting

The grantee who is awarded a contract will prepare and submit narrative and financial reports to the GCDD on a monthly basis. Narrative reports should describe progress being made in achieving performance goals specified in the Grant Contract Agreement.

A face to face performance review or presentation with the full Council is also scheduled usually in October after the project year.

Grant recipients also need to collect customer satisfaction and IPSII data from self-advocates and families to assist the GCDD in submitting a required annual performance report to the ACL. The survey form will be provided with the executed grant contract agreement.

Grant Payments

Per <u>Policy 08-08</u> reimbursement is the preferred method for making grant payments. All grantee requests for reimbursement must correspond to the approved grant budget. The State shall review each request for reimbursement against the approved grant budget, grant expenditures to-date and the latest grant progress report before approving payment. Grant payments shall not be made on grants with past due progress reports unless the GCDD has given the grantee a written extension.

Grant Monitoring

Minn. Stat. §16B.97 and Policy 08-10 Grant Monitoring require the following:

- One monitoring visit during the grant period on all state grants of \$50,000 and higher
- Conducting a financial reconciliation of grantee's expenditures at least once during the grant period on grants of \$50,000 and higher. For this purpose, the grantee must make expense receipts, employee timesheets, invoices, and any other supporting documents available upon request by the State.

Audits

Per Minn. Stat. §16B.98 Subdivision 8, the grantee's books, records, documents, and accounting procedures and practices of the grantee or other party that are relevant to the grant or transaction are subject to examination by the granting agency and either the legislative auditor or the state auditor, as appropriate. This requirement will last for a minimum of six years from the grant contract agreement end date, receipt, and approval of all final reports, or the required period of time to satisfy all state and program retention requirements, whichever is later.

Affirmative Action and Non-Discrimination requirements for all Grantees:

- A. The grantee agrees not to discriminate against any employee or applicant for employment because of race, color, creed, religion, national origin, sex, marital status, status in regard to public assistance, membership or activity in a local commission, disability, sexual orientation, or age in regard to any position for which the employee or applicant for employment is qualified. Minn. Stat. §363A.02. The grantee agrees to take affirmative steps to employ, advance in employment, upgrade, train, and recruit minority persons, women, and persons with disabilities.
- B. The grantee must not discriminate against any employee or applicant for employment because of physical or mental disability in regard to any position for which the employee or applicant for employment is qualified. The grantee agrees to take affirmative action to employ, advance in employment, and otherwise treat qualified disabled persons without discrimination based upon their physical or mental disability in all employment practices such as the following: employment, upgrading, demotion or transfer, recruitment, advertising, layoff or termination, rates of pay or other forms of compensation, and selection for training, including apprenticeship. Minnesota Rules, part 5000.3500
- C. The grantee agrees to comply with the rules and relevant orders of the Minnesota Department of Human Rights issued pursuant to the Minnesota Human Rights Act. <u>Minn. Stat. §363A</u>.

GCDD Informal Appeal Process

All applicants are informed, in writing and at the same time, about the results of the GCDD proposal review process. Applicants who do not agree with the DD Council's decision may appeal. The following steps apply to the appeal process:

- 1. An applicant who wishes to appeal must notify the DD Council in writing within 15 working days of the date on the letter informing the applicant about the decision;
- 2. The appeal letter must include the basis for the appeal. The appeal must be based on the evaluation selection criteria used by the Grant Review Committee to review and evaluate each proposal;
- 3. Upon receipt of the letter of appeal, the DD Council Chair will establish an Ad Hoc Appeals Committee. This committee will be comprised of the DD Council Chair, Grant Review Committee Chair, and at least one DD Council member who is not a Grant Review Committee member;
- 4. The Ad Hoc Appeals Committee will meet as soon as possible (in no case later than the next regular DD Council meeting) to consider the appeal;
- 5. The Ad Hoc Appeals Committee will review the deliberations of the Grant Review Committee and information presented by the applicant in the appeal letter. The Grant Review Committee may also request to hear from the applicant;
- 6. The Ad Hoc Appeals Committee review will determine if the recommendation of the Grant Review Committee appears to have been made according to the selection criteria contained in the RFP.

Because the appeal letter must be based on these criteria, the information presented by the applicant will also be considered at this time;

The Ad Hoc Appeals Committee will present its findings in writing to the applicant and the full GCDD at the next regular GCDD meeting.

SECTION 8 – DEFINITION OF TERMS (as defined in the DD Act)

Culturally competent. Services, supports or other assistance that are conducted or provided in a manner that is responsive to the beliefs, interpersonal style, attitudes, language and behaviors of individuals receiving services, and in a manner that has the greatest likelihood of ensuring maximum participation in the program.

Developmental disability. A severe, chronic disability of an individual from birth that:

- 1. Is attributable to a mental or physical impairment or a combination of mental and physical impairments.
- 2. Is manifested before the individual attains age 22.

14 Termination

14.1 Termination by the State

14.2 Termination for Cause

The State may immediately terminate this grant contract if the State finds that there has been a failure to comply with the provisions of this grant contract, that reasonable progress has not been made or that the purposes for which the funds were granted have not been or will not be fulfilled. The State may take action to protect the interests of the State of Minnesota, including the refusal to disburse additional funds and requiring the return of all or part of the funds already disbursed.
