Topic: Rebasing of the MR/RC Waiver

Overview:

In order to level off the future growth in the waiver program, DHS rebased (or recalculated) the waiver program. Rebasing was done administratively by DHS, not through the legislature. The result is a different dollar amount then was authorized previously, has been given to each county. One problem we are seeing is that there are 87 different counties and the effect of rebasing, or the amount of money (usually a reduction) varies greatly between counties. Some counties who have done a good job of using waiver dollars more efficiently have been hardest hit. We have heard this is particularly true in Dakota and Carver Counties. Smaller counties with less flexibility in their waiver budgets will also be more pressed to reduce to the level given by DHS.

One other facet of this is that DHS had hoped that by rebasing and limiting future growth in the waiver budget that this action would hold off potential serious cuts in the next round of the budget cuts to balance the 2004/05 4.5 billion dollar deficit. This may or may not be a reality. Counties received their new budgeted amounts around January 17. As far as we know today, some counties, including Hennepin and Ramsey are still working on what their response will be. Dakota County has already met with providers and told them to expect a 7% reduction, and that families can anticipate a reduction of 15 - 20% in their currently approved budgets. For example, some of the cuts counties have experienced between what they have authorized to providers and families and what they will receive from DHS are: Dakota -12%, Sherburne -9%, Ramsey -7%, Anoka - 6.5%, Hennepin -5.3%, and Carver - 20%.

What you can do immediately:

We need to hear how this has impacted counties in greater Minnesota. Chapters should call the Supervisors of the Programs for Persons with Developmental Disabilities in your counties and ask them how rebasing has impacted their county and what action the county plans to take.
