Superintendent's Monthly Report

On June 15 Rose Bros. started rasing the remaining South Wing and Center Section of the old Administration Building. Before this work was started, State Archivist, Mr. Robert Brown, and his first Assistant, Mr. Fred Thibodeau, surveyed all old records in storage at our request. The material they selected to be preserved was removed to the State Archives Commission Office on June 10th and represented the most complete institution file they have yet seen, Mr. Brown reported. He plans to set it up as a restricted exhibit available for review and study only with the approval of the superIntendant and the Commissioner, The material which was not taken by the Archives Commission and which Mr. Brown determined need not be retained by the institution was destroyed by burning.
