SUBJ: Sex Education

Premise: The mentally retarded are developing persons who have a right to as normal and happy a life as possible; this includes recognition of and provision for human sexuality. All residents, regardless of level of retardation could benefit from this knowledge in accordance with bis needs and his capacity to use it. This area is a part of the total plan of care for each resident which can best be formulated and implemented by the unit team.

Residents currently learn about sex from their peers and patient cars staff, frequently when we are not even aware that they are. being influenced. If our attitudes, ideas and feelings are not clear, we cannot effectively plan for meeting their needs.

#### Recommendations:

- 1. That members of , the Program Committee acquaint themself with the handout which the Department of Public Welfare distributed at the Oak Terrace Workshop on Sex Education.
- 2.. That members of this Program Committee become familiar with the pamphlet "How Your Child Learns About Sex."
- 3\* That each unit select personnel to attend a presentation by Mr. James Merrill.
- 4. That following Mr. Merrill's presentation each unit select an individual to represent them on a committee which would assume the role of a) developing overall guidelines, b) serve as a resource for material and c) act as a source of consultation for those who implement programs in this area.

# HAND-OUT DISTRIBUTED AT STATS WIDE WORKSHOP ON SEX EDUCATION HELD AT OAK TERRACE

PREMISE: Mentally retarded persona should have sex education and family planning services.

both in the institutions and in the community, according to individual needs and individual capacity to comprehend and use such education and services,,

### BASES FOR PREMISE:

- 1. A basic right of individuals in this country is the right to education\* An area of education should not be arbitrarily excluded.
- 2c The Department of Public Welfare has issued a policy bulletin stating that family planning services shall be given to clients.
- 3. "the mentally retarded" range from profoundly retarded to borderline and. functionally retarded. They range in age from birth to old age. Many may be exposed to a nearly full gamut of life experiences.
- 4. The basic goals for both community and institution programs for the mentally retarded are to help the individual to function more adequately in the community or in the institution, to help the individual to live as normal a life as possible, and to help the individual to live as happy a life as possible.
- 5. "The mentally retarded" are human beings, many of whom have the same sex drives and need for sexual satisfaction as human beings of normal mentality.
- 6. The majority of the mildly retarded have physically normal bodies, and the majority of the mildly mentally retarded will spend most of their lives outside of institutions. Therefore, many may be involved in some degree of sexual contact during their lives. A basic sex education may help these persons conduct themselves more appropriately.
- 7. Many mildly retarded persons will marry. with or without proper consents and counselingo A basic education in acceptable sexual behavior, on reproduction, and on methods of family planning may help these individuals to function better as spouses and aa parents.
- 8. Skills in marital counseling, as well as methods of family planning have improved so that—. v?ith the inclusion of family life—sex education, more meaningful human relations, more stable marriages, and more adequate child bearing and child rearing may be expected.

Family life sex education is interpreted here in the broadest sense to include the concept of human sexuality have complex physical, psychological and social dimensions. Family planning (birth control) provides means for individuals to decide if and when to have children the number of children they wish, and the time between children.

9. With the mildly and more severely retarded, education on appropriate sex related behavior may help them to conduct themselves less conspicuously, which could lessen exploitation and could lessen community fears of inappropriate sexual behavior.

### PROPOSED POLICY STATMENT

Family life-sex education and family planning services shall be included in the general education and treatment plans for mentally retarded persons. These services shall be given in accordance with the retarded person's needs and his capacity to comprehend and use such instruction. Encouragement and assistance shall be given to staff members involved in implementing these services.
